Emergency Motion showing Imminent Danger
of serious harm present and future; requesting
immediate release from the Federal Bureau of Prisons
Custody per 28 U.S.C. 1915(g).

I, Zumar DuBose, moves this Court by this emergency motion to be immediately released from the Federal Bureau of Prisons Custody for the reason of imminent danger of serious physical & mental harm presently and future, per 28 U.S.C. 1915(g).

(Relief and order)

- 1) Release me immediately from the FBOP custody,
- 2) Home confinement if needed.
- 3) Declaration declaring imminent danger of serious physical & mental harm present & future risk.
- 4) Government to intervene.

I, Zumar DuBose, swear under oath and declare under penalty of perjury that the statements made by me in this motion are true and accurate and made with my personal knowledge of the facts which are as followed:

(I). Imminent Danger of present and future risk of serious mental & physical harm per 28 USC. 1915(g)

1). Starting December 3rd, 2020 through April 16th, 2026 Every day the United States of America and it's FBOP unit officers placed me in imminent danger of Coronary Heart Disease, by forcing me to breathe second hand marijuana smoke, second hand K-2 synthetic chemical smoke, second hand PCP smoke, second hand meth. smoke, second hand tobacco ^{smoke}, and burned toilet paper smoke ~~through~~ the FBOP ventilation system for more than 3 hours in a row in the early morning hours of 12 am - 6 am every single day of my detention and sentence. Present and future risk of Coronary Heart Disease.

2). On February 16 2026 the United States of America and it's FBOP unit officers forced me to breathe second hand marijuana smoke, second hand PCP smoke, and second hand tobacco smoke thru the FBOP ventilation system at 1:18 am for approximately 3 hours causing me to have blood shot watery eyes, mucus with blood in it, change in my voice, migraine that lasted 10 hours in row,

Second hand intoxications, hallucinations, worsening of my mental disease. ~~that~~ that is ~~not~~ not being treated by the FBIOP but the FBIOP knows I was ordered to treat me, hearing voices, present & future risk of coronary heart disease, frontal cortex brain damage risk (future & present), weezing, unnecessary coughing, future & present risk of emphysema, risk of asthma, dizziness, thoughts of suicide for approximately 8 hours

3) On February 19 2026 the United States of America and its FBIOP unit officers forced me to breathe second hand meth smoke, second hand marijuana smoke, second hand PCP smoke, and second hand tobacco smoke thru the FBIOP ventilation system at 2:45 am for approximately 3 hours causing me the exact same injuries and risk I stated in paragraph 2 of the section (I), including second hand intoxications. All against my will & consent.

4) On April 16th 2026 the United States of America and its FBIOP unit officers forced me to breathe second hand k-2 synthetic smoke, second hand PCP smoke, second hand marijuana smoke and second hand tobacco smoke thru the ventilation system at 12:39 am for approximately 3 hours causing me the exact same injuries and risks I stated in paragraph 2 of the (I) section of the motion.

(II). The United States of America and the Federal Bureau of Prison has neglected to Care for me per 18 USC 4042

- 1) Starting December 3rd 2020 through April 16th 2026 Everyday the United States of America and it's FBOP unit officers neglected to treat my mental illness and denied me any medical care for my mental illness and symptoms I suffer; such as hallucinations that I have Everyday starting 12-3-2020 through today 4-16-2026, voices I hear, my thoughts of suicide, unable to concentrate or undisturbed.
- 2) Starting December 3rd 2020 through April 16th 2026 Everyday the United States of America and it's FBOP unit officers neglected to care for me by failing to sanitize my bedding, my cell sink, toilet with urine and human feces on it, floor with urine on it, showers with human feces and semen on the walls and floor, and all common areas & recreation areas. The USA & FBOP unit officers never sanitized at all. Not one day has sanitation cleaned. Loss of dignity.
- 3) Starting December 3rd 2020 through April 16th 2026 Everyday the USA and the FBOP unit officers neglected to care for me by providing me with a damage or torn 1 inch thick and 5 ft long cotton ~~that has urine stains~~ to sleep on that has not been sanitized, has urine stains, and vomit stains & odor, 4 of 6 which caused & still causes me neck pain, back pain, & leg pain in the hours of 12 am - 6 am for approximately 2 hours. loss of dignity.

4) Starting December 3rd 2020 through April 16th 2026 everyday the USA and the FBOP unit officers neglected to care for me by forcing me to breathe mold thro the ~~shower~~ FBOP shower ventilation system for approximately 15 minutes every time I shower, causing me present & future risk of emphysema, asthma, Cardiac Arrest. Loss of dignity

5) Starting December 3rd 2020 through April 16th 2026 everyday the USA and the FBOP unit officers neglected to care for me by forcing me to sleep on the top bunk bed without a ladder or any alternative stepping device causing me to hurt my feet, legs, and lower back each time I jump up to get on the bunk bed and each time I jump down to get off the bunk bed. Loss of dignity


6) Starting December 3rd 2020 through April 16th 2026 everyday the USA and the FBOP unit officers or medical employees neglect to care for me by failing to check ~~and~~ treat my A1C sugar levels, my hypertension blood pressure levels, my ^{high} cholesterol levels, my Body Mass Index, my teeth, or an check ups as the law requires.

7) Starting 12-27-2025 through April 16th 2026
the USA & FBOP unit officers neglected to care for
me by failing to fix the broken floor tiles in the shower
which caused me to fracture my right ^{6A} Great toe on my
right foot. I slip on fall, without any medical treatment or X-ray. I no denial.

8) Starting 12-3-2020 through 4-16-2026 for over 5 years the USA & FBOP
unit officers neglected to care for me by forcing me to drink ^{open} spoiled & rotten milk
over 100 times and Rotten & spoiled apple for 100 different times.

Conclusion

This court should grant my ~~imminent~~ immediate release
from the FBOP custody and deplore by depuration
my imminent danger of serious physical & mental harm present & future.
