Re: Application for Extension of Time to File Petition for Certiorari

Dear Justice Kagan,

I respectfully request a 60-day extension of time to file a petition for a writ of certiorari in Jeffrey Myers, et al v. Dale Sundby (Dale Sundby, Trustee as Movant and Appellant), California Superior Court Case No. 37-2021-00055006-CU-UD-CTL, 4DCA1 Case No. D084372, and California Supreme Court Case No. S289544. I am proceeding pro se.

The California Court of Appeal issued its opinion on January 21, 2025. The California Supreme Court summarily denied the petition for review on April 23, 2025. Accordingly, the petition for certiorari is currently due on July 22, 2025.

I am concurrently preparing a petition for rehearing en banc in two consolidated federal appeals pending before the Ninth Circuit, due July 16, 2025 (based on a July 2, 2025 opinion), while managing multiple overlapping federal cases pro se. These obligations, combined with the July 4th holiday and seven federal court filings over the past 60 days, make it difficult to complete the petition within the standard 90-day window.

The petition will include a dispositive constitutional question, whether a sole trusteebeneficiary may appear pro se to protect his sole undivided trust interest, that has not been addressed on the merits by five different state and federal courts. Because each declined to rule on this threshold issue, substantial care is required to properly frame the federal question and supporting grounds.

I therefore respectfully request a 60-day extension, to and including September 22, 2025, to prepare and file the petition.
