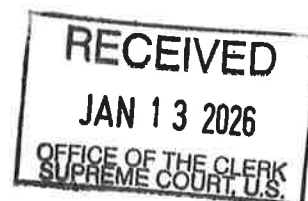


Counsel for the Respondents have been noticed and I am looking for a company to print my Brief and Appendix and following the rules of court.
