The case presented to Circuit Justice ALITO is — by any measure —

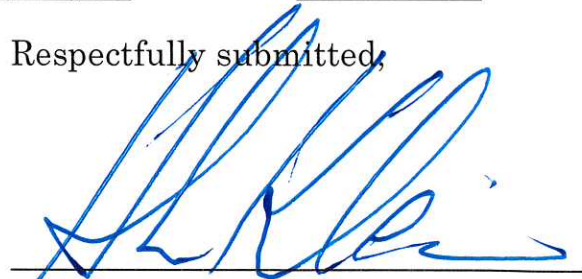
