MOTION FOR EXTENSION OF TIME TO PAY DOCKET FEE AND FILE
PETITION FOR WRIT OF CERTIORARI

To the Honorable Clerk of the Supreme Court of the United States:

Petitioner, *Shane Stevens, pro se*, respectfully moves this Honorable Court for a thirty (30) day extension of time in which to pay the docket fee and file his Petition for a Writ of Certiorari pursuant to Supreme Court Rule 33.1.

1. Petitioner's Motion to Proceed *In Forma Pauperis* was denied on 10/14/2025 without explanation. As a result, Petitioner must comply with Rule 33.1 and pay the docketing fee of \$300.
2. Petitioner lacks the current financial means to pay both the docket fee and the costs of producing forty (40) booklet copies of the Petition as required by Rule 33.1, as well as three (3) copies for service on Respondent and one (1) personal copy.
3. Petitioner must outsource the booklet production to a commercial print shop to comply with the Court's specifications. The estimated cost for printing, trimming, binding, and packaging is approximately \$1,300, in addition to the \$300 docket fee.
4. This combined expense creates a substantial financial hardship. Without an extension, Petitioner will be unable to file the Petition within the prescribed time, resulting in dismissal for financial reasons rather than lack of merit.
5. Accordingly, Petitioner respectfully requests a thirty (30) day extension from the current due date to pay the docket fee and file the Petition for a Writ of Certiorari pursuant to Rule 33.1.
