

**SWORN DECLARATION UNDER PENALTY OF PERJURY**

I, Patrick C. Coppen, Esq., being sworn upon my oath do hereby depose and state under penalty of perjury that the following statements are true, and within undersigned counsel's personal knowledge, information and belief:

1. That declarant is the Court Appointed Attorney for Arizona Death Row Inmate Julius Jarreau Moore (ADC#218107);
2. That declarant has prepared and is filing by U.S. Mail and by e-filing same with the United States Supreme Court's Clerk's Office the foregoing *2<sup>nd</sup> Corrected Application to Extend Time to File Petitioner Julius Jarreau Moore's Petition for Writ of Certiorari* from the Arizona Supreme Court's Denial of Review of his Petition for Review from the summary dismissal of his Post Conviction Relief (PCR) or Collateral Appeal;
