MOTION TO EXTEND TIME
FOR FILING PETITION FOR REVIEW

TO THE HONORABLE U.S.SUPREME COURT:

Jerry Lee Flores, pro se, Petitioner, moves this Court to grant an extension of time to file a Petition for Review, and respectfully states:

1. On July 30, 2025 the Texas Court of Criminal Appeals denied Petitioner's application for state writ of habeas corpus, and making the 90 days due date around October 28, 2025 to file a petition writ of certiorari in the U.S. Supreme Court.
2. On October 23, 2025 Petitioner left in the William P. Clements Unit Law Library his petition for Writ of Certiorari in forma pauperis to have U.S. Postage attached and have it mailed out to the Supreme Court Clerk for filing.
3. The Clerk sent the intire petition back stating it was time barred to be filed and that the Oct. 28, 2025 deadline had passed, however, the Clerk may not have known of Supreme Court Rule 29.2 on inmate mailbox rule, because Petitioner had complied with the requirements, and after getting the petition back it was found that the inmate unsworn declaration was mastakenly in one of the Appendix.
4. Under Supreme Court Rule 29.2; *Houston v Lack*, 487 U.S. 266, 276, 108 S.Ct. 2379, 101 L.Ed.2d 245 (1988) (for the proposition that a prisoner's filing will be deemed to have been made on the date it was Submitted for mailing in the prison's internal mail system, not the date of receipt. see also *Domench v United States*, 2019 U.S. Dist. LEXIS 39836.
- 5, On December 1, 2025 the Clements Unit went on annual lock-down that last


around 30 days, and making the internal mail system even slower. On Dec. 5, 2025 Petitioner received back his Writ of Certiorari he had left in the Law Library on Oct. 23, 2025.

6. An extension of time is needed to refile the petition for writ of certiorari for Review In Forma Pauperis, although, under Supreme Court Rule 29.2, and *Houston, v. Lack*, 487 U.S. 266, Petitioner's Writ of Certiorari should be deemed filed on Nov. 17, 2025 when the Clerk receipted it as being timely filed on Oct. 23, 2025. being on lock-down inmates only have contact through what is called I-60's, and that is what the Exhibits A & B Request forms to the the Law Library and the unit's mailroom for information on when the petition was handled by their Departments

7. The extension of time to file is also needed due to this time of year the holidays, around 30 to 45 days are requested, and the fact that petitioner is indigent, being on lock-down makes it hard to get the postage needed. That is why petitioner also needs confirmation by the Court as to resubmit the Petition, and cannot not waste postage.

8. For these reasons Jerry Lee Flores requests that this Court Grant His Motion to Extend Time to File Petition for Review Writ of Certiorari In Forma Pauperis will be due on or before _____. (date).
