FIRST SUPPLEMENT TO EMERGENCY APPLICATION TO JUSTICE KAVANAUGH FOR
IMMEDIATE STAY AND CRIMINAL REFERRAL

Directed to the Honorable Brett M. Kavanaugh, Associate Justice

Circuit Justice for the Eighth Circuit

Petitioner supplements the Emergency Application filed December 29, 2025, with new evidence of continued and escalating retaliation, as well as clerk tampering with the record.

1. Escalation of Overt Aerial Retaliation

Immediately following the filing of the Emergency Application and related supplements:

On December 29, 2025, at 4:28 PM, two parallel aerial lines appeared overhead at the park after printing and sending the application (Exhibit M).

On December 30, 2025, at 12:41 AM, a bright, stationary object hovered directly in front of Petitioner's residence on Ring cam (Exhibit N).

Multiple helicopters and aerial objects swarmed during travel on December 29–30 (Exhibit O).

This overt, multi-agency harassment confirms the campaign is deliberate retaliation to induce a fatal hypertensive crisis or hemorrhagic event while Petitioner is prescribed Eliquis for a large blood clot and hypertensive crisis. Symptoms include severe lower back pain/sciatica, extreme fatigue (10+ hours sleep, still drained), ear ringing, metallic taste, dry mouth, facial tingling, and anxiety.

2. Eighth Circuit Clerk Tampering with Event Types

The docket shows repeated clerk interventions: supplements seeking "criminal referral" were locked, edited by NDG, and refiled under generic "memorandum in support" event type (Doc IDs 55917238, 55917411, 5591773, edited 12/29/2025). This pattern of post-

filing edits/locks/refiles on weekend/holiday hours constitutes further obstruction and bias to conceal felony fraud and tampering allegations.

Petitioner requests the Court consider this supplement in conjunction with the original application.

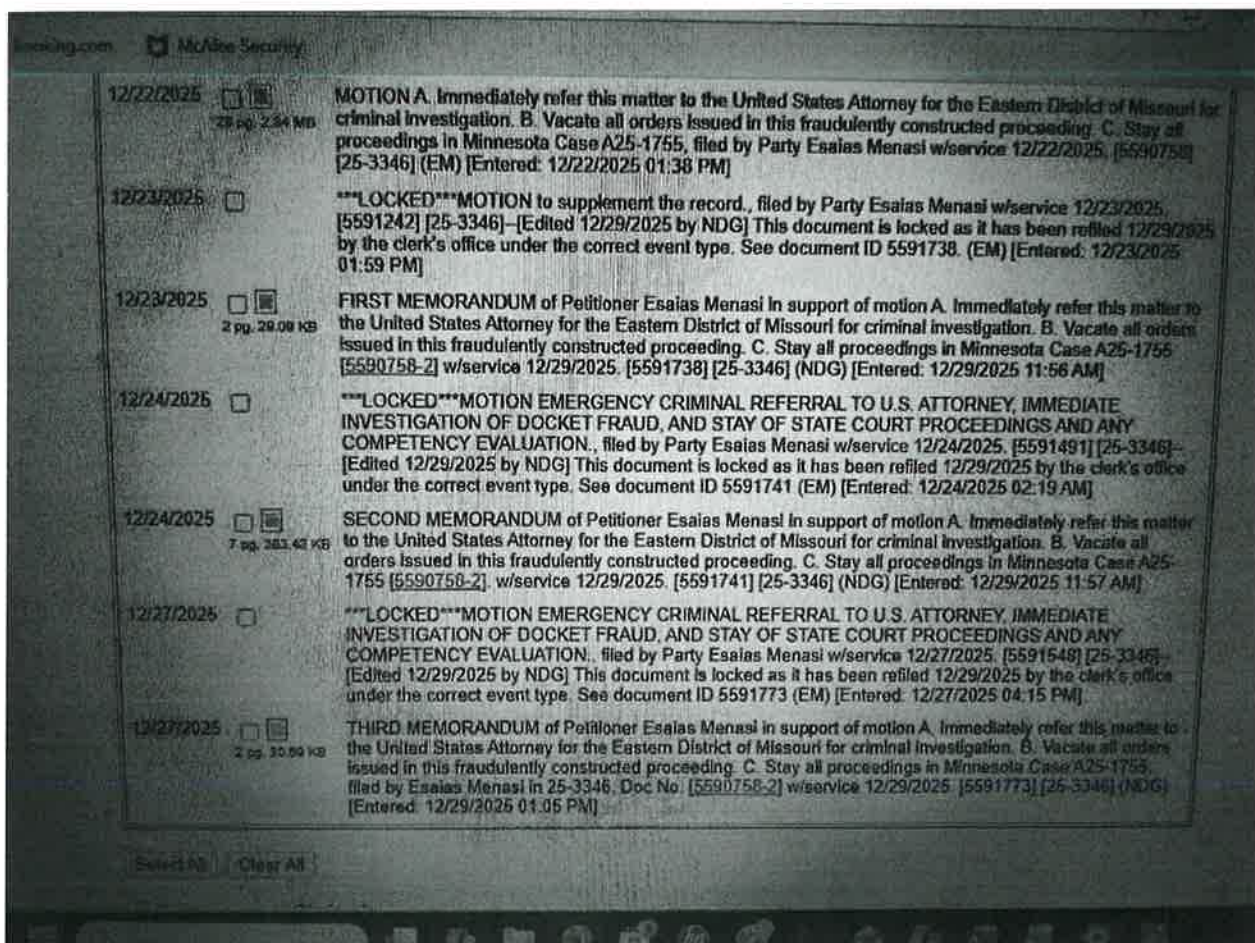
