**CORRECTIONS MADE:**

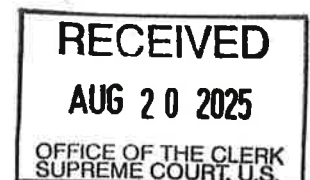
In compliance with your guidance, I have made **only technical corrections** as follows:

**1. Motion Clarification:**

- **Removed:** "Motion for Leave to Proceed In Forma Pauperis"
- **Added:** "Motion for Leave to Proceed as a Veteran" pursuant to Supreme Court Rule 40
- **Eliminated:** All references to 28 U.S.C. § 1915(a) to avoid confusion regarding filing status

**2. Appendix Corrections:**

- **Completed:** Missing pages from July 8, 2025, Federal Circuit order (Appendix B)
- **Corrected:** Exhibit organization by removing duplicate Veterans Court case from Appendix B



- **Redacted:** All personally identifiable information (social security numbers, dates of birth, etc.) throughout appendices while preserving relevant factual content

**3. Technical Compliance:**
