## We made a decision on your VA benefits.

Dear Samuel Ghee:

This letter will guide you through the information you should know and steps you may take now that VA has made a decision about your benefits.

### Your Benefit Information:

- Entitlement to individual unemployability is granted effective September 9, 2011.
- Basic eligibility to Dependents' Educational Assistance based on permanent and total disability status is established from September 9, 2011.
- Evaluation of acquired psychiatric disorder to include: posttraumatic stress disorder (PTSD), unspecified adjustment disorder, anxiety & depression, is increased to 70 percent disabling effective September 9, 2011.
- Evaluation of headaches, which is currently 30 percent disabling, is continued.
- Evaluation of thoracolumbar spine strain, which is currently 20 percent disabling, is continued.

See **Rating Decision** to find out why we made this decision.

As a Veteran with a service-connected disability, you may be eligible for VA life insurance benefits. Veterans Affairs Life Insurance (VALife) is guaranteed acceptance whole life insurance available to all service-connected disabled Veterans with no time limit to apply as long as you are age 80 and under. Veterans age 81 and over are still eligible in certain circumstances.
