

MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS AND AFFIDAVIT IN SUPPORT

TO THE HONORABLE CHIEF JUSTICE AND ASSOCIATE JUSTICES OF THE SUPREME COURT OF THE UNITED STATES:

Comes now, YASIR QAHTAN SAUD, Petitioner proceeding pro se, and respectfully moves this honorable court for leave to proceed in forma pauperis in the above captioned matter pursuant to 28 U.S.C. §1915 and supreme court rule 39. In support of this motion, Petitioner submits the following affidavit:

I, YASIR QAHTAN SAUD, being first duly sworn, depose and state as follows:

- 1). I am the petitioner in the above captioned case and make this affidavit in support of my motion for leave to proceed in forma pauperis
- 2). I am currently incarcerated in federal custody at FCI OAKDALE 2 LA. located at P.O. BOX 5010, OAKDALE, LA 71463, serving a sentence imposed by the united states district court for the eastern district of virginia.
- 3). I am indigent and unable to pay the cost of this proceeding, Including filing fees, service cost, and the expense of preparing and serving the required copies of this petition.
- 4). I have no income other than nominal prison wages that are insufficient to cover basic necessities, let alone legal expenses.
- 5). I have no assets, savings, or other financial resources available to pay for the cost assiciated with this petition for Writ of certiorari.
- 6) I have no family members or other persons who are able or willing to pay the cost of this proceeding on my behalf.

- 7). Due to my incarceration, I have no access to employment or other means of generating income to pay for legal expenses.
- 8). I have no bank account, Investments, Real property, Or other assets of value.
- 9). Any money i receive in my prison account is used for basic necessities such as food, hygiene items, and communication with family members.
- 10). The filling fee for a petition for Writ of certiorari in this court is \$300, which i am unable to pay.
- 11). The cost of preparing and serve 40 copies of this petition, as required by this court's rules, would be prohibitively expensive and beyond my financial means.
- 12). The cost of service on the respondent through the solicitor general would also be beyond my financial means.
- 13). I am proceeding pro se because i cannot afford to retain counsel for this proceeding.
- 14). Despite my indigent status, I believe that the constitutional violations and legal issues presented in this petition are of such importance that they warrant this court review.
- 15). The issues presented in this petition involve fundamental constitutional rights and systematic government misconduct that affects not only my case but has broader implications for the criminal justice system.
- 16). I respectfully request that this court grant my motion to proceed in forma pauperis and waive all fees and cost associated with this petition.
- 17). I further request that this court direct the clerk to serve copies of this petition on the respondent and prepare and serve the required copies due to my inability to pay for such services.
- 18). I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge and belief.
