The petition for a writ of certiorari in this case was filed on July 21, 2026. The Respondents' response deadline is August 26, 2026. We respectfully request, under Rule 30.4 of the rules of this Court, an extension of time of 30 days, to and including September 25, 2026, within which to file Respondents' response.
