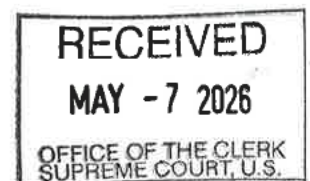

VETERAN**

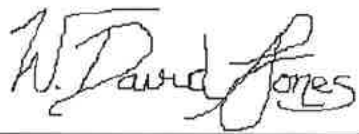
Under Supreme Court Rule 40, I, William David Jones, being first duly sworn, depose and say:
