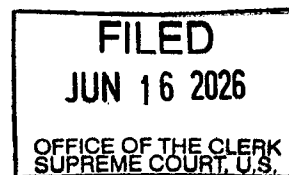

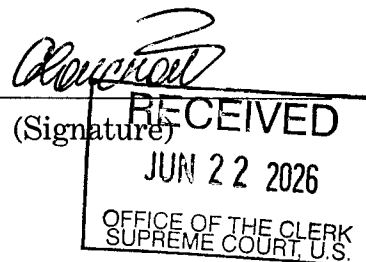

The Employment Authorization Document has not been issued by DHS to Petitioner since 2021. I, Sergey Donskoy, am the petitioner in the above-entitled case.

In regard to the Declaration in Support of Motion for Leave to Proceed *in Forma Pauperis* question 9, Petitioner expects that the Supreme Court grant *certiorari* and, after review of the petition, reverse the affirmance and vacate the dispositive order of the Court of Appeals filed March 23, 2026, that the case be eventually remanded to USCIS and the agency grant the Petitioner's I-140 petition, and that on further Petitioner's request DHS will issue EAD legally permitting U.S. enterprises to employ Petitioner for a paid work which would bring a major change to his monthly income during next 12 months.
