**DECLARATION OF TARON JACQUETT IN SUPPORT OF
MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS**

I, Taron Jacquett, declare under penalty of perjury that the following is true and correct:

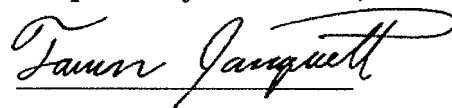
1. My sole source of income is Veterans Affairs disability compensation in the amount of \$4,393.38 per month.
2. After court-ordered support obligations, my available monthly income is significantly reduced.
3. Since September 2021, I have incurred substantial financial obligations arising from ongoing litigation.
4. These expenses include attorney's fees exceeding \$100,000, court filing fees, transcript costs, appellate record preparation costs, and a \$5,000 court-ordered purge payment.

5. I have exhausted all personal savings to meet these obligations.
6. As a 100 percent disabled veteran, I experienced a decline in my health following my incarceration, resulting in additional financial hardship.
7. I have been required to borrow money from family members, including my mother, to pay legal and living expenses.
8. The Florida Supreme Court has previously granted me leave to proceed as an indigent litigant multiple times, based upon substantially the same financial circumstances described in this declaration.
9. I have also incurred additional housing-related expenses, including temporary lodging, following court ordered dispossession from my residence.
10. My monthly expenses exceed my available income, and I do not have sufficient funds to pay the filing fee.
11. Payment of the filing fee would require me to forgo basic necessities including housing, utilities, and food.
12. I am presently unable to pay the filing fee and request leave to proceed in forma pauperis.

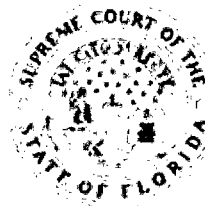

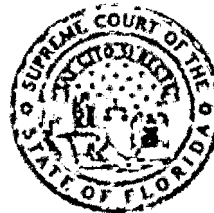
