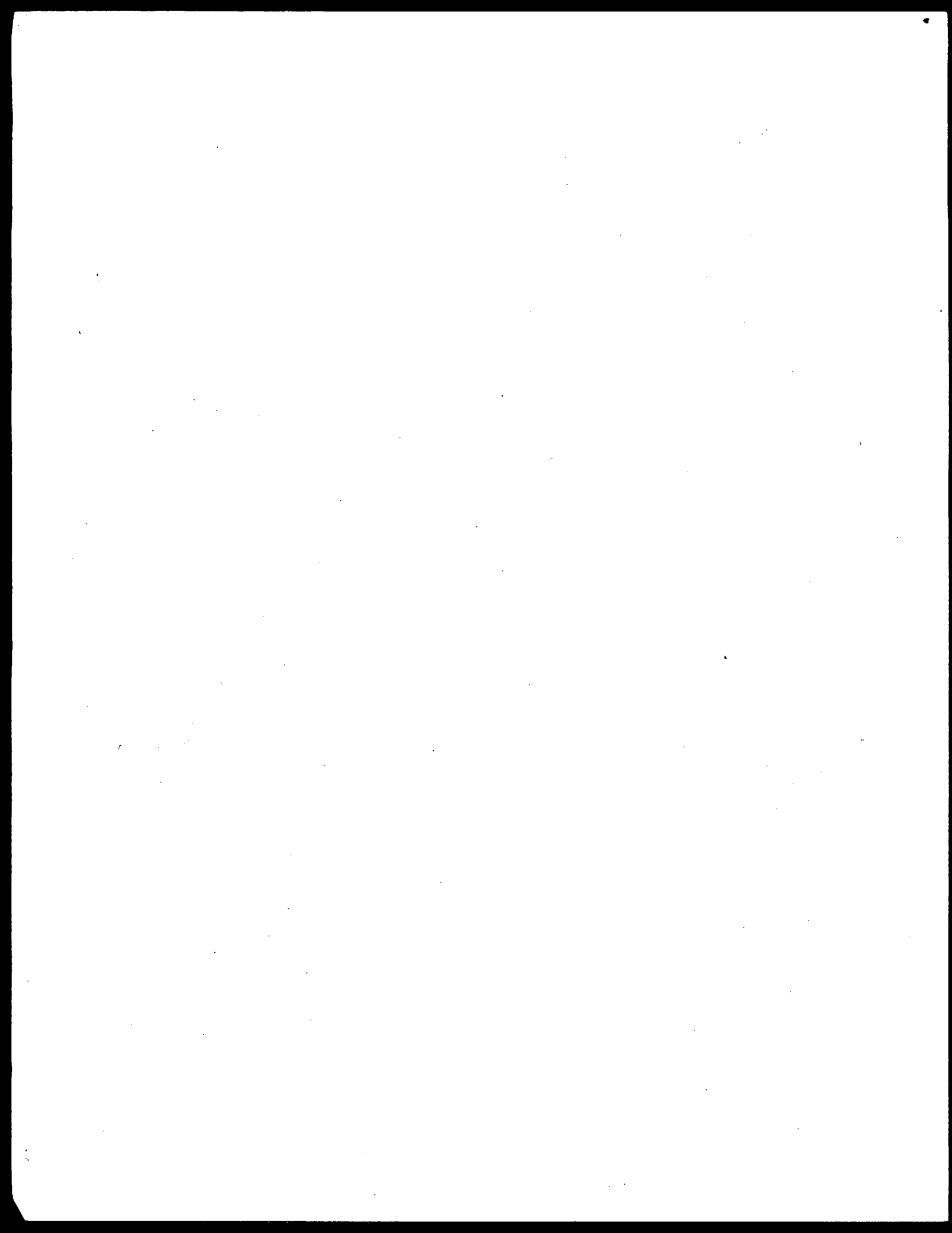


**AFFIDAVIT OR DECLARATION

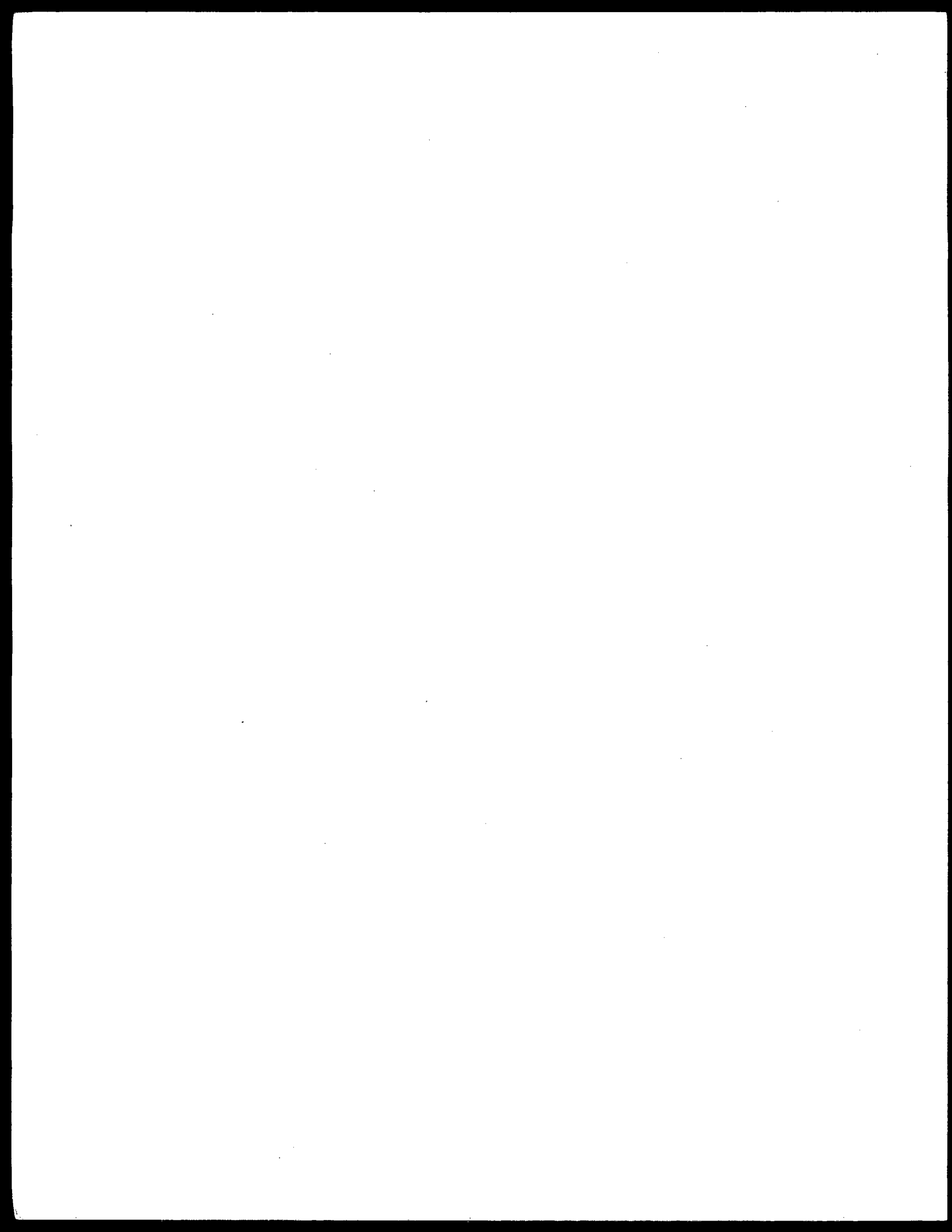

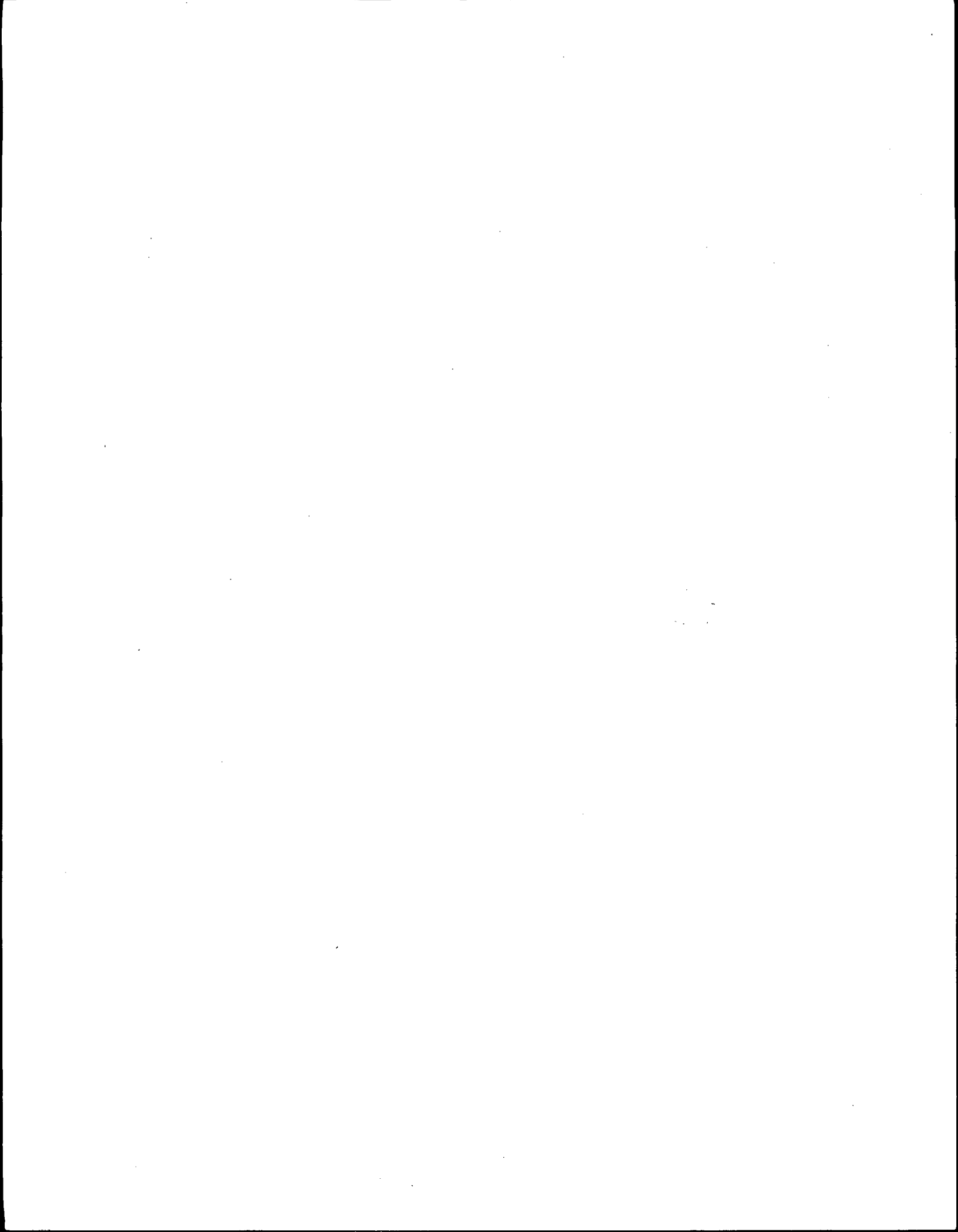

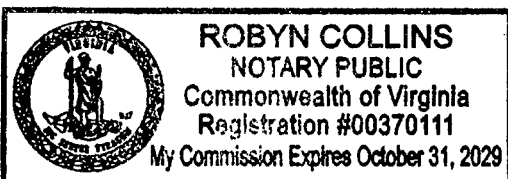
