ORDER

Before: W. FLETCHER and KOH, Circuit Judges.

Three or more prior actions or appeals filed by appellant were dismissed as frivolous, malicious, or for failure to state a claim. *See Taylor v. Biden, et al.*, Case No. 2:24-cv-00431-IM (D. Or. March 11, 2024) (dismissed for failure to state a claim); *Taylor v. Brown, et al.*, Case No. 2:24-cv-00438-IM (D. Or. March 11, 2024) (dismissed for failure to state a claim); *Taylor v. United States of America, et al.*, Case No. 2:24-cv-00432-IM (D. Or. March 13, 2024) (dismissed for failure to state a claim). Appellant has not alleged imminent danger of serious physical injury. The motion (Docket Entry No. 3) to proceed in forma pauperis is therefore denied. *See* 28 U.S.C. § 1915(g).

Within 21 days, appellant must pay \$605 to the district court in fees for this appeal and file proof of payment with this court. If appellant does not pay the fees, the court will dismiss this appeal, regardless of further filings. *See* 9th Cir. R. 42-1.

No motions for reconsideration, clarification, or modification of the denial of appellant's in forma pauperis status will be entertained. If the appeal is dismissed for failure to pay fees, the court will not entertain any motion to reinstate the appeal that does not include proof of payment.

Briefing is stayed .

IMMERGUT, District Judge.

Plaintiff Jermel A. Taylor, a self-represented litigant in custody at Eastern Oregon Correctional Institution, filed this civil rights action pursuant to 42 U.S.C. § 1983. On December 31, 2024, the Court determined that Plaintiff is barred from proceeding in forma pauperis pursuant to 28 U.S.C. § 1915(g) and ordered him to prepay the \$405.00 filing fee within thirty days (ECF No. 3). The Court advised Plaintiff that failure to pay the filing fee within thirty days would result in the dismissal of this action.
