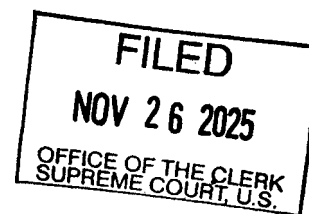

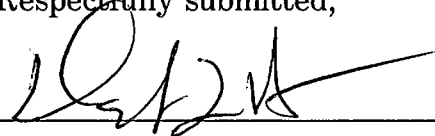
I NEED Your Help Because a Circuit Judge
