1. Petitioner has previously been granted leave to proceed in forma pauperis in the following court(s): Maricopa County Superior Court, Phoenix, Arizona.

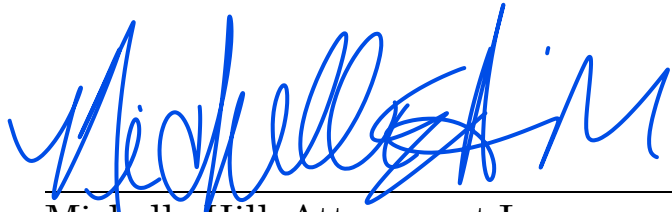

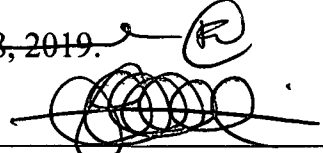
ORDER ON AMENDED REQUEST TO
