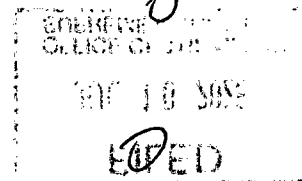
AFFIDAVIT OR DECLARATION

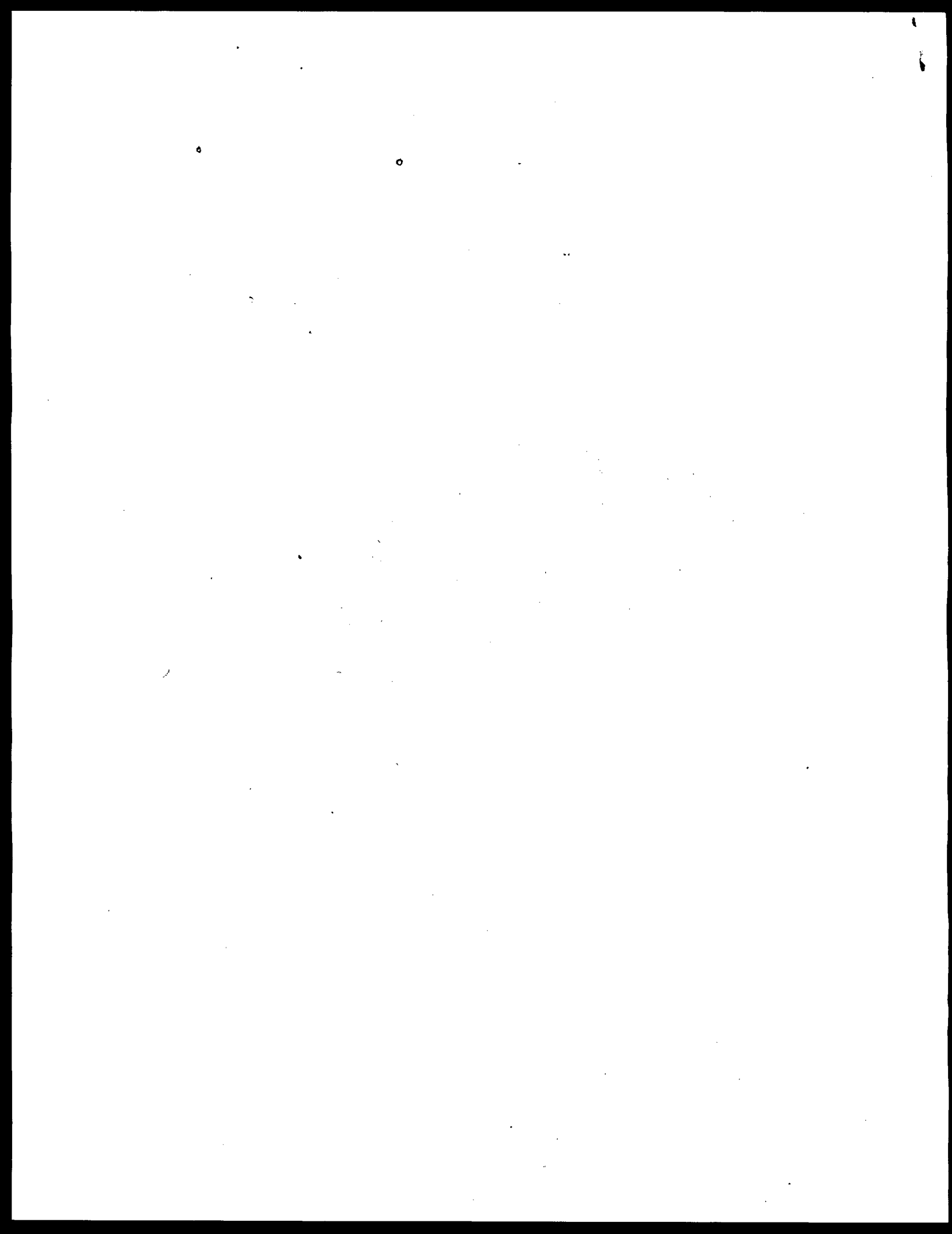

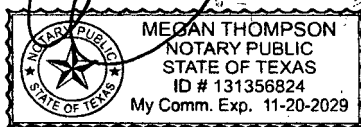
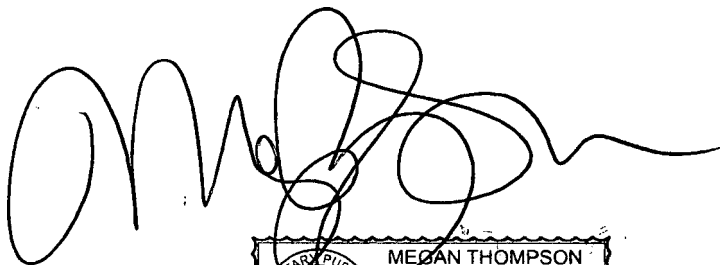
