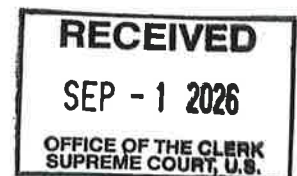

**SECOND APPLICATION FOR AN EXTENSION OF TIME
WITHIN WHICH TO FILE A PETITION FOR A WRIT OF CERTIORARI**

To the Honorable Clarence Thomas, Associate Justice of the Supreme Court of the United States and Circuit Justice for the Eleventh Circuit:

1. Pursuant to Supreme Court Rule 13.5, Petitioner Nancy Tyson respectfully requests a thirty (30) day extension of time, to and including October 8, 2026, within which to file a petition for a writ of certiorari to review the judgment of the District Court of Appeal of Florida, First District (“First DCA”), in Case No. 1D2024-2405.
2. This Court has jurisdiction under 28 U.S.C. § 1257(a). The First DCA is the highest state court in which a decision on the merits of this case could be had. The Supreme Court of Florida lacks jurisdiction to review a *per curiam* affirmance issued without a written opinion. See Fla. Const. art. V, § 3(b)(3); *Jenkins v. State*, 385 So. 2d 1356 (Fla. 1980).
3. This case arises from a civil action filed in the Circuit Court of the Eighth Judicial Circuit, in and for Alachua County, Florida, Case No. 2023-CA-001552. The circuit court dismissed the action after granting Defendants/Appellees’ Motion for Judgment on the Pleadings. [The Order Granting Motion for Judgment on the Pleadings is attached as Attachment A.] Petitioner timely appealed to the First DCA, Case No. 1D2024-2405. On March 26, 2026, the First DCA *per curiam* affirmed the judgment below without a written opinion. Petitioner timely filed a Motion for Rehearing and Rehearing En Banc, or Alternatively Motion for Issuance of a Written Opinion and Certification. The First DCA denied that motion on May 11, 2026. [Copies of

the *per curiam* affirmance and the order denying rehearing are attached as Attachments B and C.]

4. Your Honor has already provided Petitioner with a 30 day extension (Application # 26A159). Petitioner now requests a second 30 day extension, to and including October 8, 2026. Such an extension would provide Petitioner a full 60 day extension from its original deadline to file its petition for writ of certiorari pursuant to Rule 13.5. Absent an extension, the petition would be due on September 8, 2026. This application is filed more than ten days before that deadline, as required by Rules 13.5 and 30.2.
5. Petitioner worked diligently to meet its September 8th, 2026, deadline; however, due to unforeseen and unavoidable circumstances Petitioner will likely be unable to meet its current deadline. Petitioner, having been made aware of the Court's August 17th, 2026, monthly review of applications for admission, diligently worked towards filing its application in a timely manner. Petitioner mailed its application for admission on August 10, 2026, via certified overnight mail. Petitioner's application was still, nonetheless, scheduled to be delivered on August 13, 2026. However, due to circumstances beyond Petitioner's control, its application for admission was not delivered to the Court until August 17, 2026. (Petitioner's application's tracking history is attached as Attachment D). As Such, it is Petitioner's belief the Court was unable to review Petitioner's application for admission to the U.S. Supreme Court Bar during its August 17th review of applications for admission. These

unforeseeable and unintended circumstances would leave Petitioner without the ability to file its petition for writ of certiorari by the Court's September 8, 2026, deadline. Petitioner respectfully requests a second extension of time of 30 days in order to receive timely admission to the U.S. Supreme Court Bar.

6. Further Good cause exists for the requested extension. This case presents a complex and unsettled question of federal law: whether Title III of the Americans with Disabilities Act, 42 U.S.C. § 12181 et seq., and the private cause of action it affords, preempts application of chapter 400, Florida Statutes — and, in particular, the exclusive-remedy provision of that chapter — to a nursing-home resident's disability-discrimination claims. Sound development of the petition requires careful analysis of the interaction between federal disability-rights law and Florida's statutory scheme governing long-term care litigation, and of how other courts have treated analogous preemption questions. Moreover, an extension of time would provide Petitioner with ample time to review historical records regarding congressional intent behind the enactment of the Americans with Disability Act, which would be central to the Court's understanding of whether federal preemption exists in this instance.
7. That task is complicated further because the First DCA affirmed by unelaborated *per curiam* affirmance, without a written opinion stating its reasoning. Counsel must therefore reconstruct, from the full record and the parties' briefing below, the grounds on which the decision may rest in order to properly frame the questions presented and address every plausible basis for

the ruling — a task considerably more time-consuming than responding to a reasoned opinion.

8. The additional time requested is necessary for undersigned counsel to research these issues thoroughly, review the record, prepare a petition that will be of maximum assistance to the Court, and most crucially, be able to file a petition for the Court's review. This application is made in good faith and not for purposes of delay, and the requested extension will not prejudice Respondents.

For the foregoing reasons, Petitioner respectfully requests that the time within which to file a petition for a writ of certiorari be extended thirty (30) days, to and including October 8, 2026.
