Corrected Application For Extension of Time

Comes Now, Petitioner, Roosevelt Charles Booth, herenow, Respectfully Files
this corrected application for an extension of time.

The application for an extension of time was originally Filed on
Jan. 7, 2026 in a timely manner.

The lower Courts opinion was not appended to the original application,
and the court determined it was impossible to determine the timeliness
of my application for an extension of time without the lower Courts
opinions.

The order rendered on June 27, 2026 in response to my motion
requesting court to reconsider hearing petition "FLSC SC2025-1625"
States that: "Once the application is corrected and Filed, an extension
of at least 10 days would render the petition timely Filed."

Appended to the corrected application is the lower Courts opinion.

As acknowledged in the response to my motion requesting court to
reconsider hearing petition, the date of the lower Courts Judgment or
order denying a timely petition for rehearing was Oct. 20, 2025; Therefore,
The petition was due on or before Jan. 18, 2026.

Indeed, I missed the deadline but it wasn't my fault. I repeatedly asked the
government officials to make copies of the petition for me for a month
straight. I requested the law library to come get the petition, they came but
refused to take the petition with him, then didn't come back until nearly
a month later. I filed two grievances on the matter but was
still delayed because they overlooked the filled out copy request

that was attached, Causing me to miss my deadline.

Please hear this case, I'm an innocent man getting beat in prison by these government officials due to the nature of my charges. They punch me, Choke me, Kick me, Stomp me, Stand on top of me, they ruptured my eardrums, and beat me with a wooden cane.

Please hear this case, the trial Courts proceeding and my conviction is in direct conflict with multiple cases, Statutes, treaties, Laws and provisions and violates my Federal and State Constitutional Rights. The trial Courts proceedings and my conviction is in direct conflict with the Supreme Courts rulings. (See, Strickland vs. Washington, 104 S.Ct. 2052 80 L.Ed. 2d [No. 82-1557]; Mooney v. Holohan, 294 U.S. 103, 112, 79 L.Ed. 791, 794, 55 S.Ct.; Stephens v. State, 974 So. 2d 455, 457 (Fla. 2d DCA 2003); Brady v. Maryland, 373 U.S. 83, 83 S.Ct. 1194, 10 L.Ed. 2d 215; Bell v. State, 569 So. 2d 1322 (Fla. 1st DCA 1990).

Moreso, I filed for an extension of time in a timely manner but did not have copies of the papers to send to the court. (or else I would've just sent the petition for certiorari in) so the court didn't give me an extension of time and returned my request to me.

Please consider the following and hear this case:

1. I'm illegally convicted and the decision is in direct conflict with a number of this courts decisions
 2. I tried for over a month to get copies but the law library wouldn't come get my petition at first, and then when they came and got it, refused to make copies, and by the time they finally made the copies, I had already missed the deadline.
 3. There is an innocent man sitting in prison right now getting beat by government officials due to the nature of my charges I was falsely accused of. (They knocked the teeth out of my mouth already).
 4. I might have missed the deadline but it wasn't my fault and I did try to file for an extension of time in a timely fashion but my motion was returned to me because (again) I didn't have copies of the documents needed.
- Please hear this case, I shouldn't be in prison and I don't deserve to be repeatedly beat and nearly killed by these government officials.
