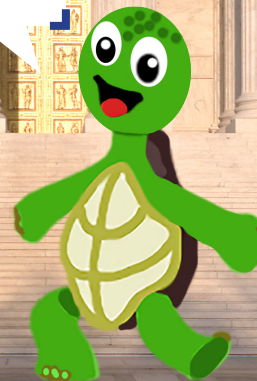


Learn with Lex: A Children's Guide to the Supreme Court

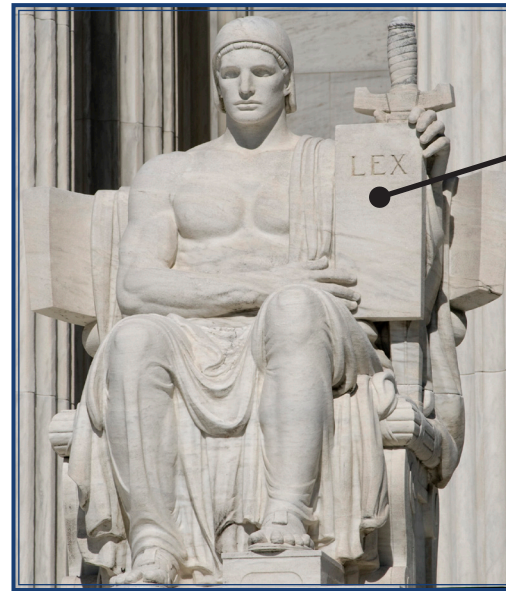
What looks the same?

In 1935, clothing styles were different. Many visitors in the photo are wearing suits and nobody is wearing jeans. Hats were common, too!



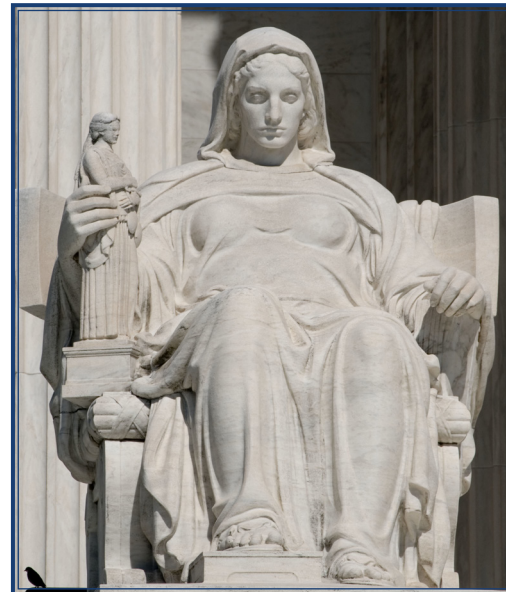
The two large statues outside the building are missing! They were added shortly after the building opened. They are called *Authority of Law* and *Contemplation of Justice*.



Authority of Law

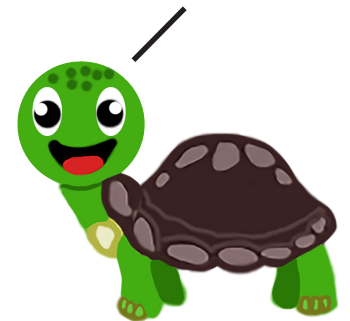


Can you see the word *Lex* written on the tablet? That is how you say the word *law* in Latin.



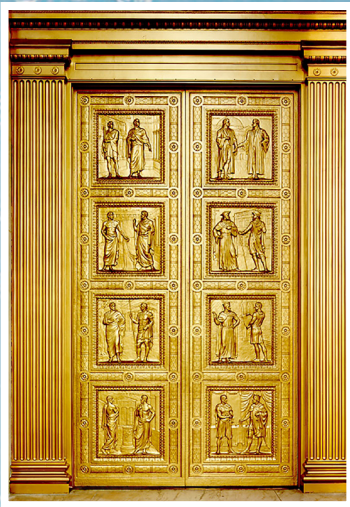
Contemplation of Justice

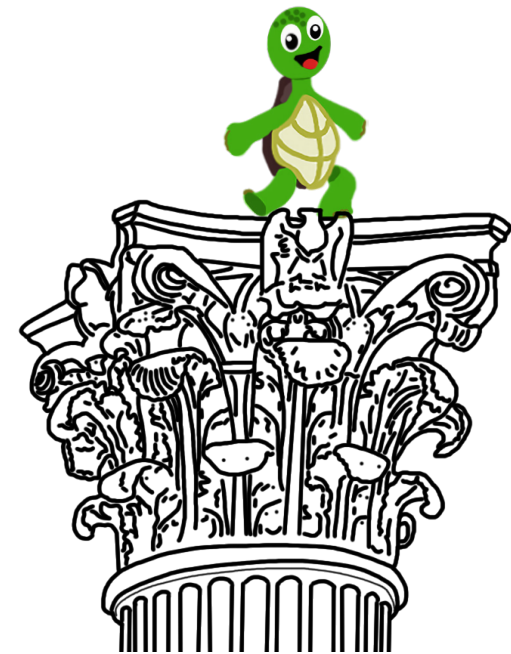
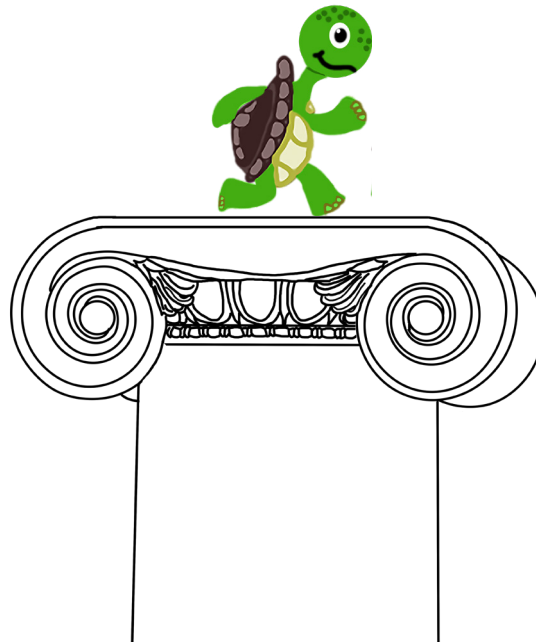
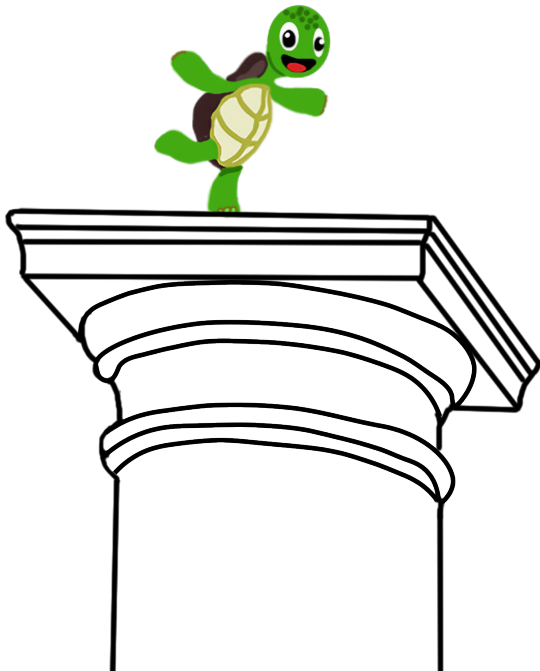

**CORINTHIAN
COLUMNS**
are the fanciest.
They have
flowers and
leaves on top.

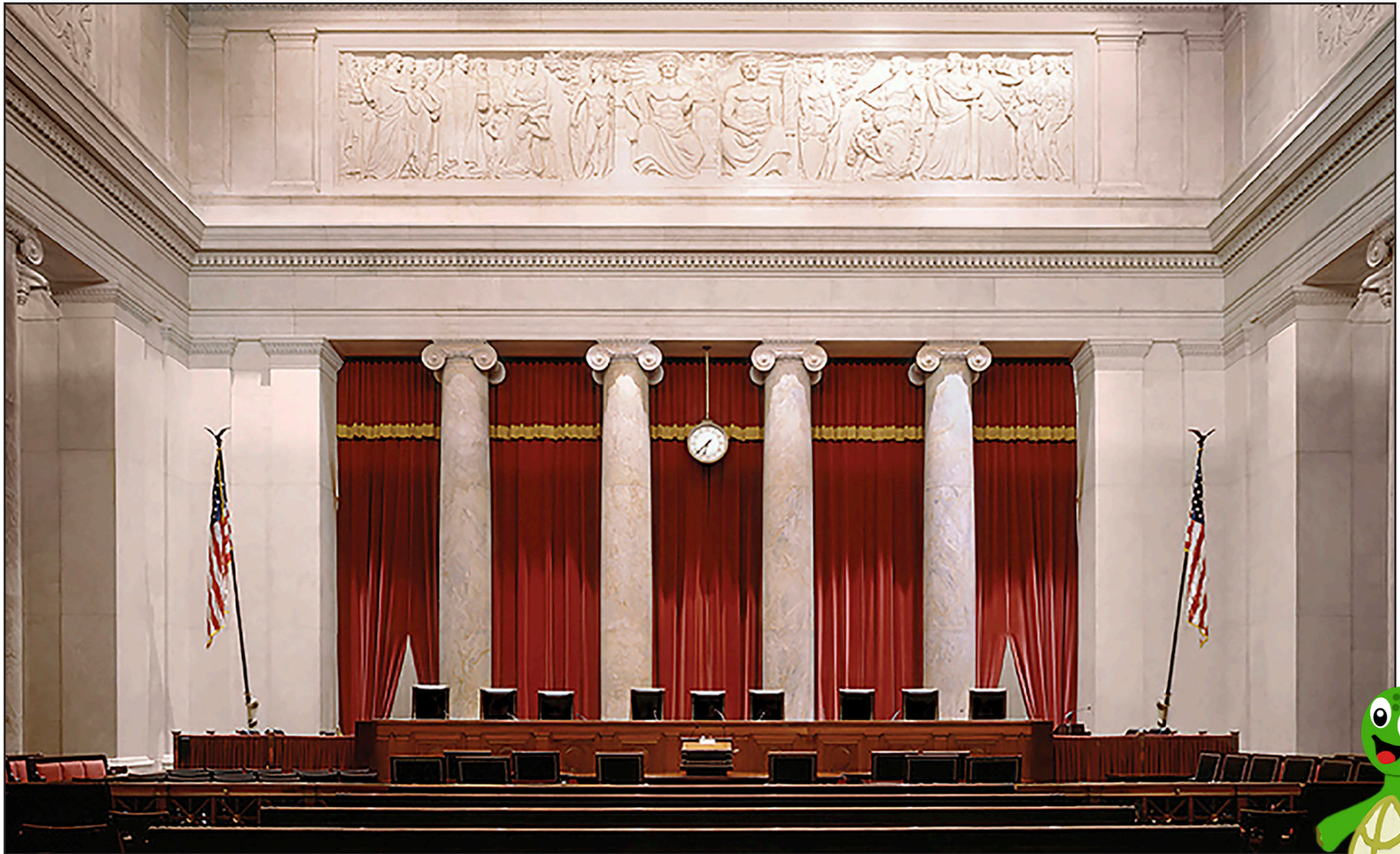

The Courtroom

The Supreme Court is often called “the highest Court in the land” because it makes decisions all other courts in the country must follow. The Courtroom is where the Supreme Court Justices sit to hear oral arguments and announce their decisions.



ORAL ARGUMENT is when lawyers argue their case in front of the Justices. These arguments help the Justices make their decisions.





Courtroom Seek & Find

The American Flag: There are two—one on each side of the Bench. ▶



The Lectern: Lawyers stand here, directly in front of the Bench, and face the Justices during oral arguments.

Ionic Columns: There are columns all around the Courtroom. Each one has a scroll at the top. ▼

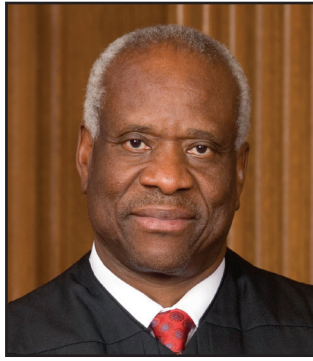


The Bench: This is where the nine Justices sit when they hear oral arguments in the Courtroom. The Bench is angled so they can see and hear each other better.

There are **9** Supreme Court Justices.
The Justices make important decisions about our country's laws.

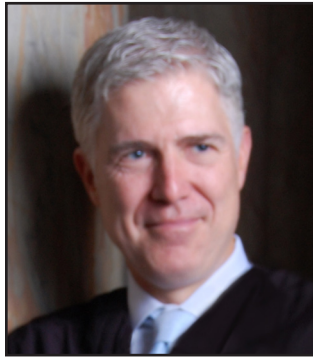

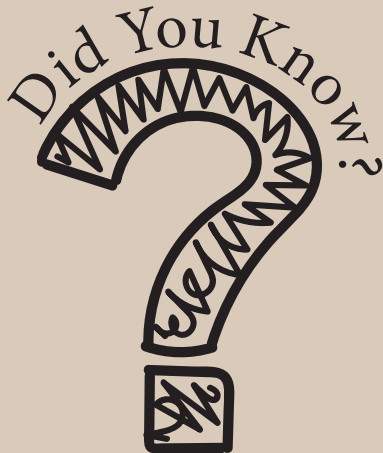

There is no rule or dress code that says each Justice has to wear a black robe. It is a **TRADITION**, something the Justices have been doing for more than 200 years.

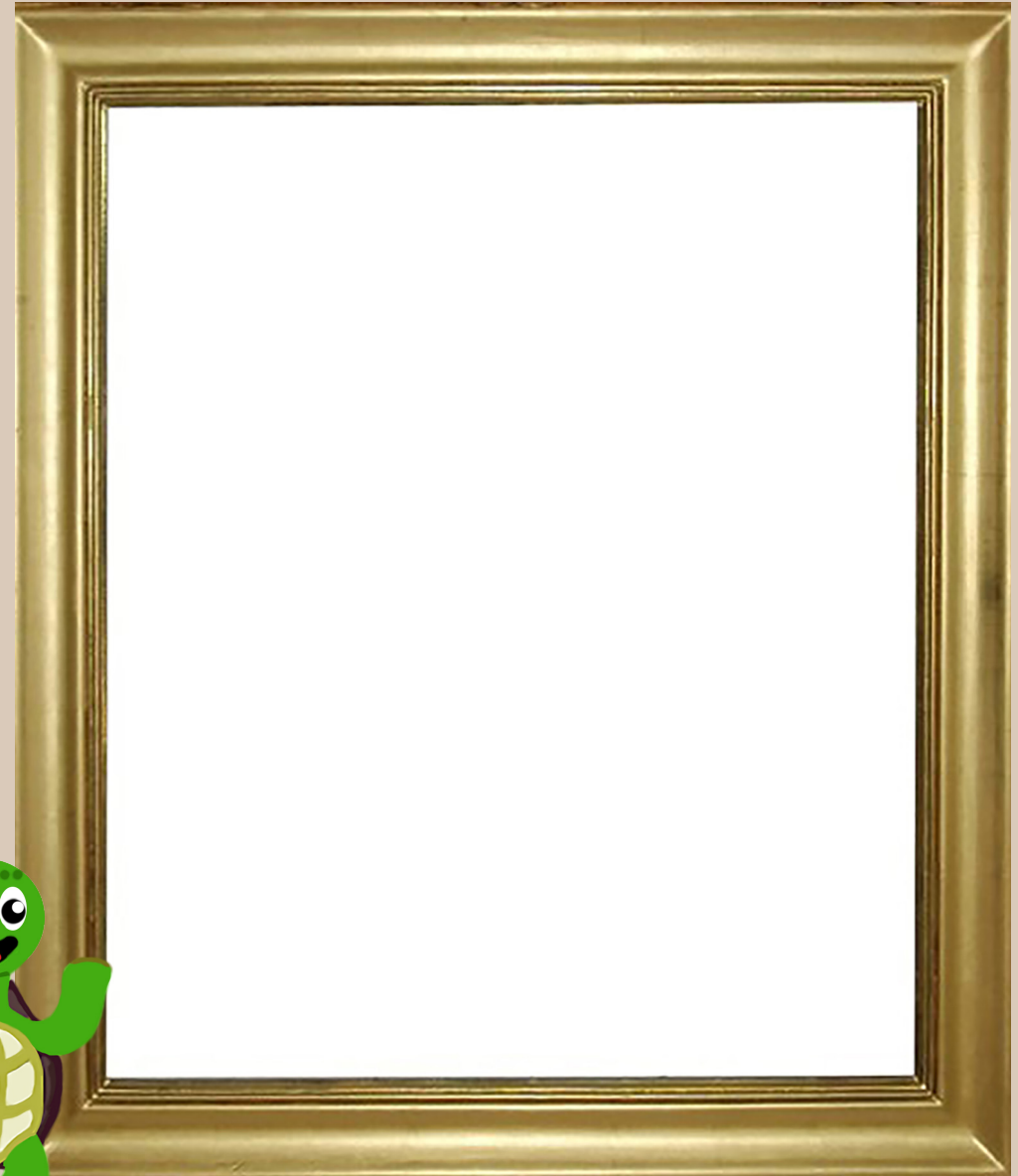

A **PORTRAIT** is a painting of a person, often someone famous. This is a portrait of Justice Sandra Day O'Connor, the first woman to become a Supreme Court Justice.



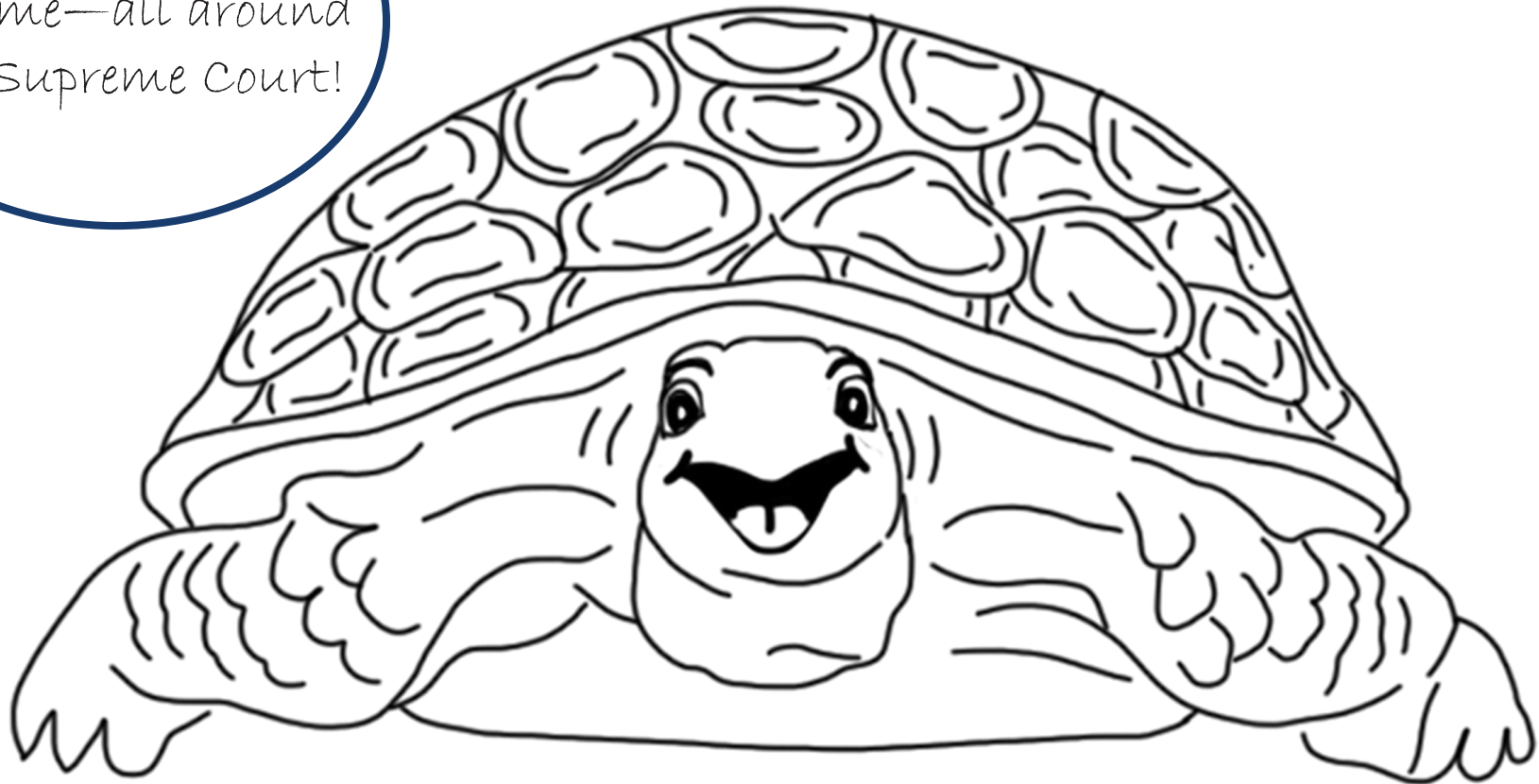
LET'S COLOR!

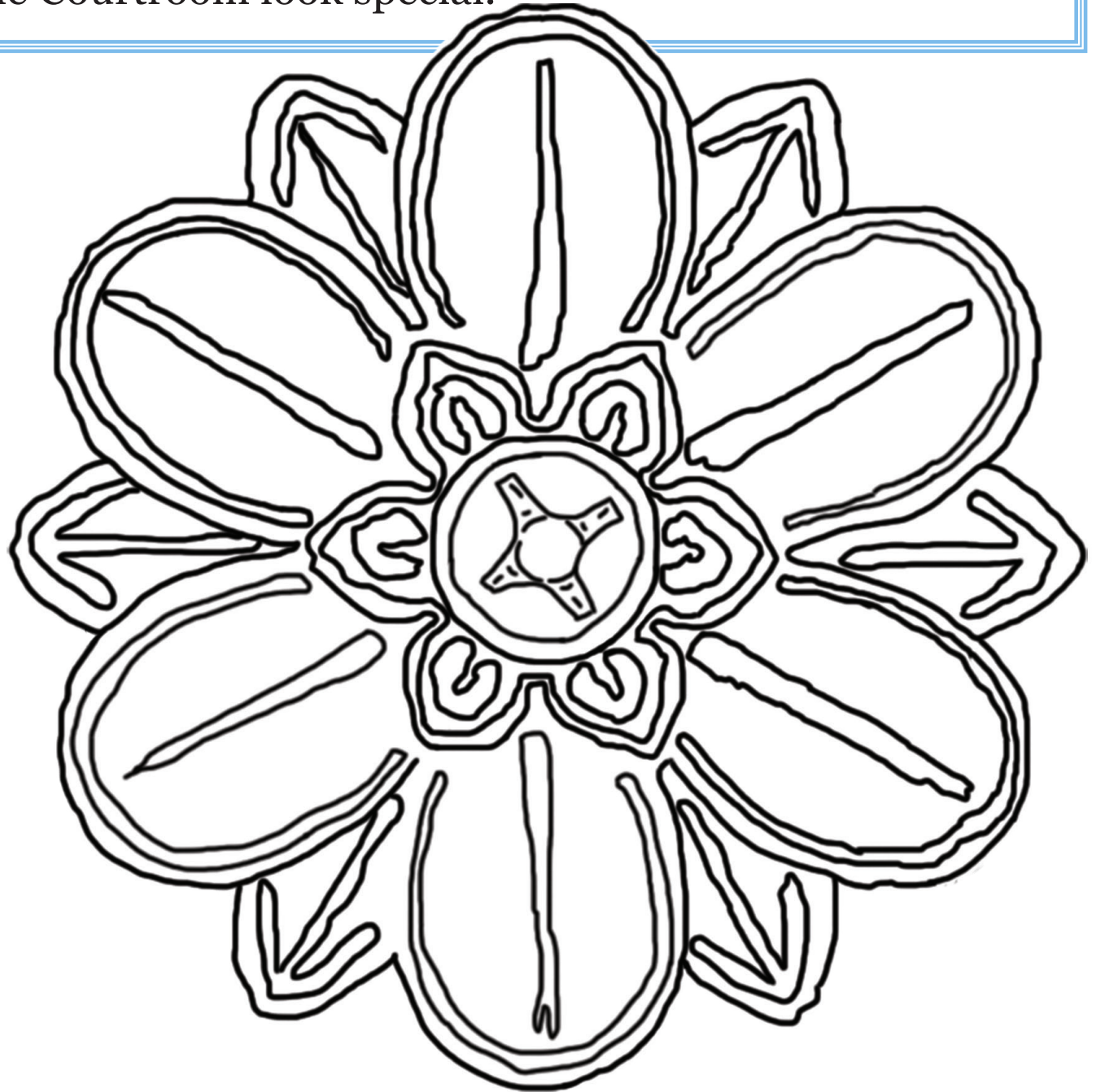
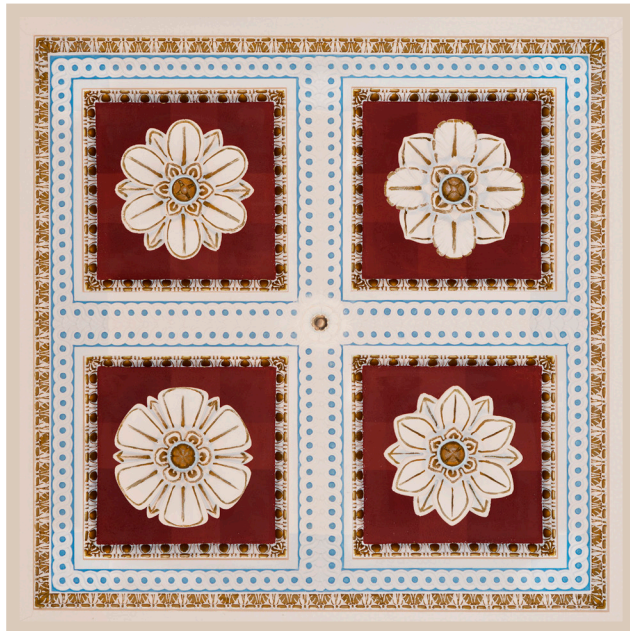

the Supreme Court!

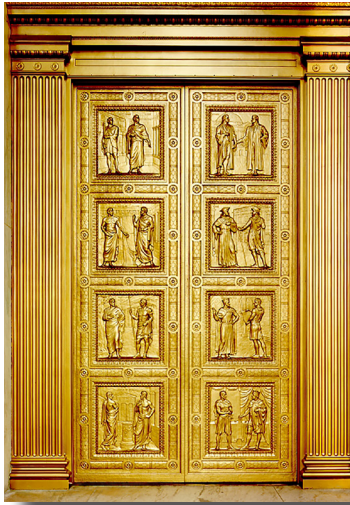


There are beautiful flowers on the ceiling in the Great Hall and the Courtroom called **ROSETTES**. These flowers are not symbols. The rosettes were added to make the Great Hall and the Courtroom look special.

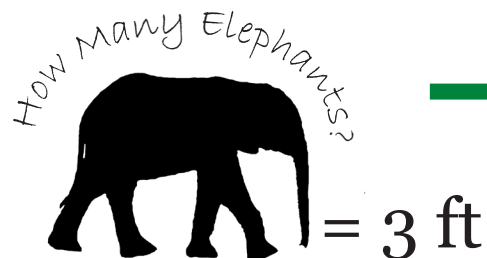

The columns in the Great Hall are **Doric Columns**.



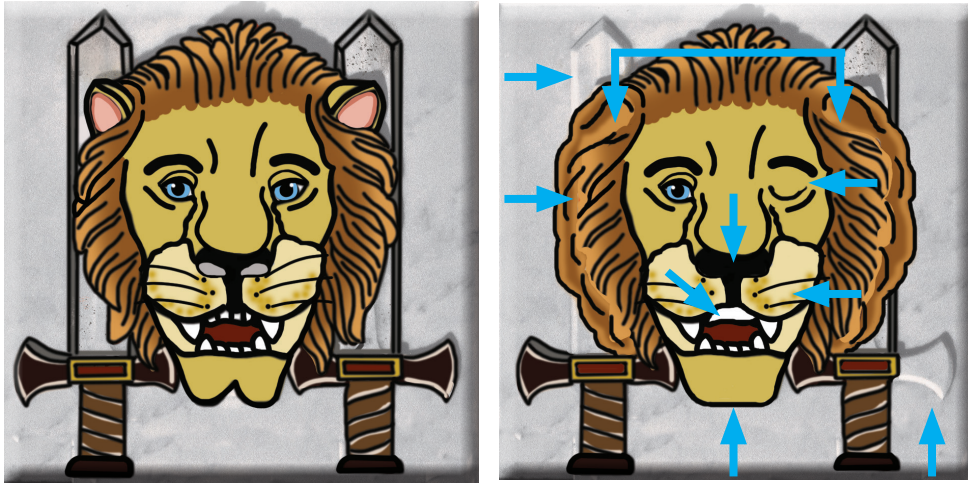

Each column is just over **24** feet tall. One column is almost the same size as **8** baby elephants!



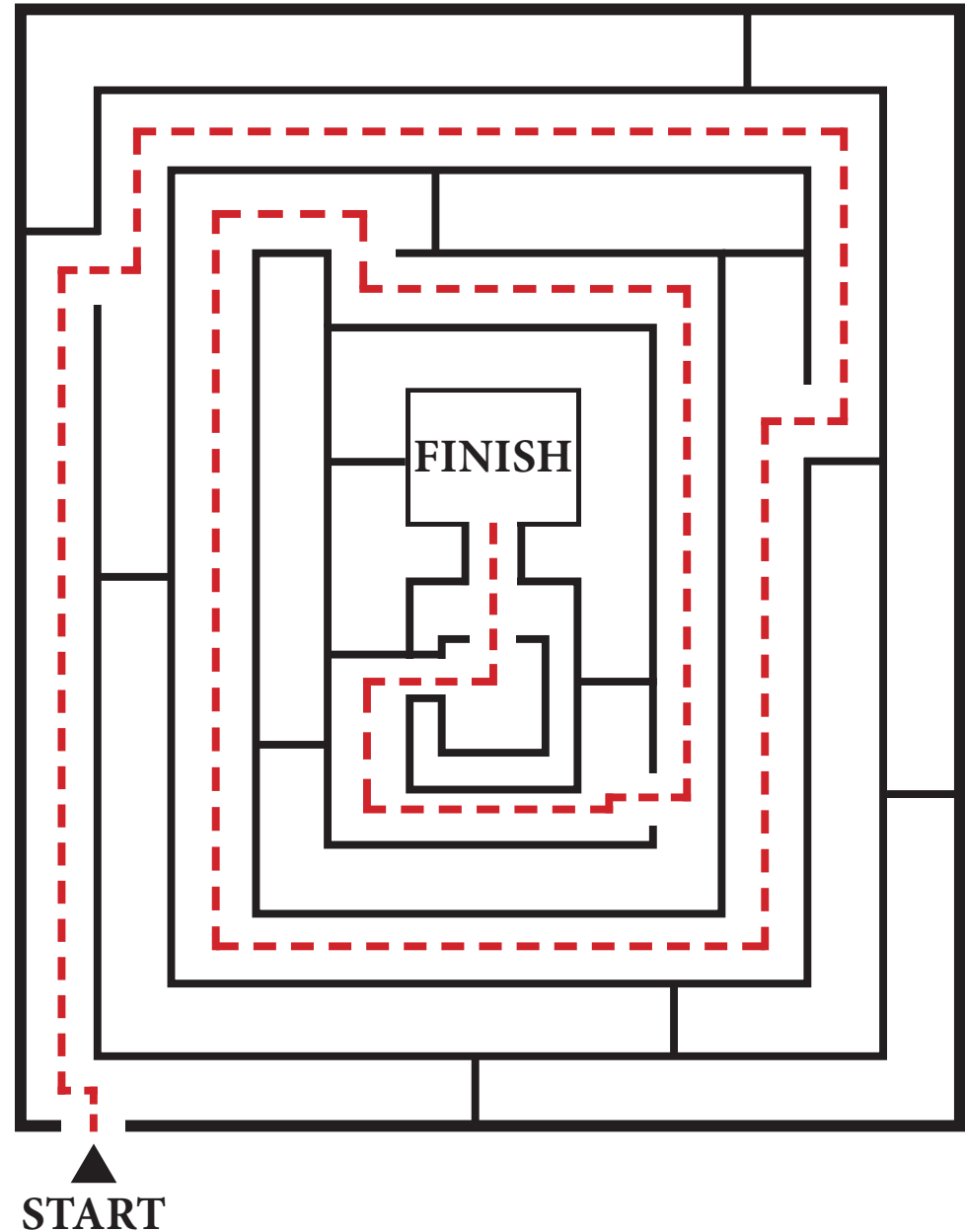

WE LEARNED NEW WORDS TODAY!

Architect: A person whose job is designing buildings.

Doric Column: Plain and sturdy columns.

Ionic Column: A fancier type of column that has a scroll at the top.

Corinthian Column: The fanciest type of column. They have leaves and flowers at the top.

Oral Arguments: Cases the Justices hear at the Supreme Court.

Tradition: Something that is passed down from one person to another.

Portrait: A painting of a person, often someone famous.

Symbol: An image or object that stands for something else.

Rosette: A fancy word for a flower decoration.
