Uniform Crime Reports

The Uniform Crime Reporting (UCR) Program was conceived in 1929 by the International Association of Chiefs of Police to meet a need for reliable, uniform crime statistics for the nation. In 1930, the FBI was tasked with collecting, publishing, and archiving those statistics. Today, several annual statistical publications, such as the comprehensive ***Crime in the United States***, are produced from data provided by nearly 17,000 law enforcement agencies across the United States.

Other annual publications, such as ***Hate Crime Statistics*** and ***Law Enforcement Officers Killed and Assaulted*** address specialized facets of crime such as hate crime or the murder and assaults of law enforcement officers respectively.

Special studies, reports, and monographs prepared using data mined from the UCR's large database are published each year as well. In addition to these reports, information about the ***National Incident-Based Reporting System (NIBRS)***, ***UCR Frequently Asked Questions***, and ***UCR Incident Specific Questions*** are also available on this site.

- *UCR Handbook*

The *UCR Handbook* outlines the classification and scoring guidelines that law enforcement agencies use to report crimes to the UCR Program. In addition, it contains offense and arrest reporting forms and an explanation of how to complete them. The Handbook also provides definitions of all UCR offenses.

This publication presents supplemental UCR statistics auxiliary to those published in Crime in the United States with regard to age-specific arrest rates and race-specific arrest rates for the years 1993-2001.

National Incident-Based Reporting System

In response to law enforcement's need for more flexible, in-depth data, the Uniform Crime Reporting Program formulated the National Incident-Based Reporting System (NIBRS). NIBRS presents comprehensive, detailed information about crime incidents to law enforcement, researchers, governmental planners, students of crime, and the general public. The South Carolina Law Enforcement Division conducted the pilot demonstration of this program in 1987. Since then, implementation of NIBRS has been commensurate with the resources, abilities, and limitations of the contributing law enforcement agencies. Although participation grows steadily, data is still not pervasive enough to make broad generalizations about crime in the United States. However, several NIBRS studies and monographs are available on this site that demonstrate the great utility of NIBRS. Data collection and submission guidelines and NIBRS Frequently Asked Questions and NIBRS Incident Specific Questions are available as well to help law enforcement agencies with the implementation of and participation in NIBRS.

a wife or girlfriend in 2.8 percent of the incidents. (Based on Table 2.12.)

Offenders

Reviewing the supplemental data for which age, sex, and race of offenders were known revealed that 90.3 percent of murder offenders were male, and 91.7 percent were over the age of 18. Considering those offenders for which race was known, 50.3 percent of murder offenders were black and 47.2 percent were white. Persons of other races comprised 2.5 percent of offenders. (Based Table 2.6.)

Supplemental data for 2001 indicated that of those incidents with one victim and one offender, 93.6 percent of black homicide victims were killed by a black offender, and 85.4 percent of white victims were slain by white offenders. (See Table 2.8.)

Weapons

Reviewing those incidents in which the murder weapon was known demonstrated that 69.5 percent involved the use of a firearm. Within the firearm category, handguns were used in 77.9 percent of homicides, shotguns were used in 5.7 percent, and rifles in 4.5 percent. Other or unknown firearms accounted for 12.0 percent. Knives or cutting instruments were employed in 14.3 percent of homicides for which the weapon was known. Personal weapons such as hands, fists, or feet, etc. were used in 7.4 percent of murders. Blunt objects were the weapon used in 5.3 percent of murders. Other dangerous weapons (such as poison, explosives, etc.) accounted for the remainder. (See Table

for murder were under the age of 25. (See Table 41.)

Arrest Rates

Based upon 2002 arrest data and population figures, the Nation's rate of arrest for murder was 4.9 arrests per 100,000 inhabitants. By region, the South and the Midwest each had murder arrest rates of 5.7, the West had a rate of 4.6, and the Northeast experienced 3.2 murder arrests per 100,000 population. (See Table 30.)

Among population groups, the Nation's cities collectively had a murder arrest rate of 5.2 per 100,000 persons. The largest cities, those with 250,000 and over in population, registered the highest rate—10.4 murder arrests per 100,000 inhabitants. The lowest rate, 2.2 murder arrests per 100,000, was calculated for cities with 10,000 to 24,999 residents. Murder arrest rates for rural counties and suburban counties were, respectively, 4.0 and 4.3 arrests per 100,000 persons. (See Table 31.)

Arrest Trends

A comparison of 2002 murder arrest data to those of 2001 indicated a 1.9 percent decrease for the period. Arrests of adults also decreased, 2.2 percent. However, juvenile arrests increased 1.5 percent. By gender, murder arrests of males increased 0.1 percent, and those of females fell 15.2 percent. (See Tables 36 and 37.)

The 5-year trend data showed that overall murder arrests for 2002 fell 10.7 percent from the 1998 arrest level. Arrests of juveniles dropped 35.6 percent, but arrests of adults decreased 7.0 percent. An analysis of gender data for 1998 through 2002 showed that arrests of males for murder declined 10.6 percent, and arrests of females for murder dropped 11.0 percent. (See Tables 34 and 35.)

From 1993 to 2002, murder arrests fell 40.9 percent. Arrests of juveniles were 64.3 percent under the 1993 figure, and arrests of adults were 36.3 percent lower. The 10-year trend also revealed that arrests of males for murder were down 41.5 percent; arrests of

murderers, and 29.1 percent were related to them. Husbands and boyfriends killed 32.3 percent of female victims, and wives and girlfriends murdered 2.5 percent of male victims. (Based on Table 2.11.)

Circumstances

The circumstance was unknown for 33.9 percent of the homicides reported on the SHR for 2003. The supplemental data indicated that 16.4 percent of the homicides for which circumstances were known involved the commission of another felony such as robbery or narcotic drug laws. Investigators suspected that another 0.6 percent of homicides likely resulted from a felonious activity. Investigators cited arguments as the cause of 28.6 percent of the killings. Other types of circumstances, such as juvenile gang killings, sniper attacks, and brawls involving alcohol or drugs, were documented in 20.4 percent of the murders. (Based on Table 2.13.)

Clearances

In the UCR Program, law enforcement clearances occur by arrest or, in certain specific circumstances, by exceptional means, i.e., when elements beyond the control of law enforcement prevent the placing of formal charges against the offender. (Section III provides more information regarding clearances.) Typically, the crime of murder has the highest percentage of clearances. During 2003, law enforcement cleared 62.4 percent of murders reported nationwide. (See Table 25.) Of the total clearances for murder, 5.2 percent involved only juvenile offenders. (See Table 28.)

During 2003, law enforcement in the Nation's cities collectively cleared 61.9 percent of reported murders.

Among the city population groupings, those with populations of 10,000 to 24,999 had the highest percentages of

strangers. Among the incidents in which the victims knew their killers, 29.8 percent were murdered by family members and 70.2 percent were killed by acquaintances. (Based on Table 2.11.) The 2004 data also revealed that 33.0 percent of female victims were killed by their husbands or boyfriends, and 2.7 percent of the male victims were slain by their wives or girlfriends. (Based on Tables 2.4 and 2.11.)

Circumstances

The supplemental homicide data showed that the circumstances were unknown for 35.0 percent of the murders that occurred in 2004. For the murders for which the circumstances were known, 22.8 percent of the murders involved another felony, such as forcible rape, robbery, or burglary. Investigators suspected that another 1.3 percent of homicides likely resulted during another felonious activity. Law enforcement cited that arguments, including those over money or property, were the cause for 44.4 percent of the murders. Other circumstances, such as brawls and juvenile gang killings, were noted in 12.8 percent of the murders. Specific circumstances were not provided for 18.8 percent of the incidents. (Based on Table 2.13.)

Clearances

Law enforcement agencies reporting crime to the UCR Program can clear, or "close," the offense in one of two ways: by arrest or, when elements beyond the control of law enforcement prevent the agency from arresting and formally charging the offender, by exceptional means. (Additional information regarding clearances is provided in Section III, Offenses Cleared.) Of all the crime categories, murder typically has the highest percentage of clearances. This trend continued in 2004 as law enforcement
