California Code of Regulations (CCR)

The California Code of Regulations (CCR), is the official compilation and publication of the regulations adopted, amended or repealed by state agencies pursuant to the Administrative Procedure Act (APA). Properly adopted regulations that have been filed with the Secretary of State have the force of law.

The CCR is compiled into [Titles](#)* and organized into Divisions containing the [regulations of state agencies](#).

The CCR is available from a variety of sources:

The online CCR contains the full text of the California Code of Regulations. OAL updates the official hard-copy and online versions of the code once weekly to reflect newly adopted, amended or repealed regulations. OAL cannot verify the authenticity of regulations downloaded from websites other than <http://ccr.oal.ca.gov/>, or confirm whether those versions reflect the existing content of the code.

CCR BROWSING TIPS:


Pop-Up Blocker/Westlaw: If a yellow "pop-up blocker detected" screen appears, you may simply click on "continue to weblinks" to access the online CCR. If a window appears stating "Westlaw is unable to accept your password," clear cookies and close your browser before trying again.

Documents in Sequence: The Documents in Sequence function at the bottom of each section will allow you to view CCR sections in sequence. For example, if you retrieve 1 CCR § 260, click **Docs in Sequence** to view 1 CCR § 270. Use the **Prev** and **Next** arrows located at the bottom of the document to view other consecutive documents.

17 CCR § 30852

§ 30852. Utensils and Containers, Conditions of Use and Storage.

- (a) < **Multiuse** > and single service drinking utensils and ice buckets shall be protected from dirt, vermin, droplet infection, overhead leakage, and other potential contamination during handling, storage, and distribution.
- (b) < **Multiuse** > drinking utensils or ice buckets may be used in guest rooms under the following conditions:
- (1) They are thoroughly washed and sanitized after each use.
 - (2) The drinking utensils, prior to distribution, are placed in protective bags with the open end of the utensil placed in the closed end of the bag to prevent handling of the lip contact surface.
 - (3) No utensil shall be labeled or otherwise indicate to have been cleaned and sanitized unless it has been cleaned and sanitized in accordance with Section 30853 and/or 30855.
- (c) Single service drinking utensils or ice buckets may be used in guest rooms under the conditions that the drinking utensils are dispensed by one of the following methods:
- (1) From a dispenser which keeps the lip contact surface enclosed.
 - (2) Individually wrapped.

(a) The Director, agents, or Registered Sanitarians appointed by the Director, and local health officers, Registered Sanitarians, and duly authorized agents thereof may at < **reasonable** > times enter and inspect any hotels, motels, or other public places governed by these regulations.

Article 5. Existing Buildings

25 CCR § 40

§ 40. < **Bedding** >.

In every apartment house or hotel subject to this part, held out for rent and furnished with a bed and < **bedding** >, every part of every bed, including the mattress, sheets, blankets, and < **bedding** > shall be kept in a clean, dry and sanitary condition, free from filth, urine, or other foul matter, and from the infection of lice, bedbugs, or other insects. The bed linen in a hotel shall be changed before a new guest occupies the bed. In every dwelling unit where linen is furnished, the linen shall be changed before a new guest occupies the dwelling unit.
