Enclosed please find Case Management Order No. 2 with revised deadlines/timelines. These revisions provide extensions which are less than what you requested but adequate, in my opinion, based on our present knowledge. The former deadlines, as you are aware, were set based on an assumption that Georgia's Answer would be filed on February 2, 2015. Following our telephone conference on December 15, 2014, Georgia accepted my suggestion and will file its Answer no later than January 8, 2015, which allowed a revised date for the

- (c) Aggressively explore settlement possibilities; and
- (d) Contact me as each deadline approaches if it proves difficult or impossible to meet rather than attempt to adjust the entire schedule en masse.
