#### PLAINTIFF'S SECOND AMENDMENT TO COMPLAINT.

The State of Missouri by leave of the Special Master, Honorable Gilbert H. Jertberg, Senior United States Circuit Judge for the 9th Circuit hereby files its amended complaint with respect to disputed lands along its common boundary with the State of Nebraska.

I.

#### AMENDMENT TO COMPLAINT.

The Lands in Dispute Are:
