**MOTION TO
LENGTHEN ORAL ARGUMENT**

Comes now the defendant, State of New Mexico, pursuant to Rule 38(3) of the Rules of the Supreme Court of the United States, and hereby moves the Court to lengthen the time allowed for oral argument to one hour. In support thereof, New Mexico states:

1. The evidence presented to the Special Master consisted in large part of technical studies relating to basin discharge, stream flow, irrigation efficiency, and the divertible supply of water available to rights in New Mexico. While the Special Master made no specific findings or conclusions, his narrative statement of the evidence shows that he misconceived the importance of some of the evidence and misapplied the significance of other evidence.

2. The Special Master made his recommendation on the basis of his understanding of nine decisions of the Court, eight of which were equitable apportionment actions wherein the Court appointed a master to hear the evidence. The Special Master did not discuss the masters' reports in the cases to which he referred, which may account in part for his misunderstanding of the case decisions.

3. This original action is of great importance to the State of New Mexico in that an adverse decision resulting from the Court's adoption of the Special Master's Report would have a profoundly adverse impact upon the economy of Colfax County, New Mexico.


4. The decision of the Court in this case will establish an important precedent that will affect rights on interstate streams throughout the western United States.

5. One half hour does not provide enough time to explicate the factual misunderstandings and explain the reasoning beneath the Court's decisions in previous equitable apportionment actions.

WHEREFORE, the State of New Mexico moves the Court to extend its time for oral argument to one hour.
