ORDER.

This cause coming on to be heard upon the motion of the defendants for leave to file their answers herein and for consolidation of said cause with cause No. 16, original in equity, October term, 1925, entitled "*States of Wisconsin, Ohio, Pennsylvania and Minnesota, Complainants v. State of Illinois and The Sanitary District of Chicago, Defendants, States of Missouri, Tennessee, Kentucky and Louisiana, Intervening Defendants,*" for the purpose of taking proofs and hearing, IT IS ORDERED:

(1) The Defendants State of Illinois and The Sanitary District of Chicago are hereby given leave to file their respective answers, including therein motions to dismiss, on or before June 1, 1926. The complainant is hereby granted leave to file replications to such answers.

(2) This cause is hereby consolidated with cause No. 16, original in equity, October term, 1925, entitled

"States of Wisconsin, Ohio, Pennsylvania and Minnesota, Complainants, v. State of Illinois and The Sanitary District of Chicago, Defendants, States of Missouri, Tennessee, Kentucky and Louisiana, Intervening Defendants," for the purpose of taking proofs and hearing.

(3) The proofs offered and testimony and evidence presented by the respective parties in cause No. 16, original in equity, October term, 1925, entitled "*States of Wisconsin, et al. v. State of Illinois, et al.*," before the special commissioner therein appointed, may be used so far as such evidence and proofs may be material and relevant in this cause, the same as if such evidence and proofs were presented and offered before a special commissioner appointed in this cause to take proofs and report the same to the court, and for such purposes the complainants and/or defendants herein may present proofs in support of the issues in this cause before the special commissioner appointed in said cause No. 16, original in equity, October term, 1925, entitled "*States of Wisconsin, et al. v. State of Illinois, et al.*"
