**Supplemental Brief of the State of California Regarding the Entering Into Force of the Convention on the Territorial Sea and Contiguous Zone on September 10, 1964.**

Pursuant to Rule 41(5) of this Court, the State of California wishes to call the Court's attention to the fact that the required number of countries have ratified the Convention on the Territorial Sea and Contiguous Zone (U.N. Doc. A/Conf. 13/L.52). The Convention was proclaimed by the President on September 8, 1964 and entered into force on September 10, 1964.

In briefs previously filed by the parties herein, it had been noted that the Convention had not yet become effective because twenty-two States had not ratified or acceded to it. Amended Exceptions of the United States to the Report of the Special Master Filed Novem-
