### MEMORANDUM FOR THE STATE OF CALIFORNIA EX REL. STATE LANDS COMMISSION IN SUPPORT OF ITS MOTION FOR SUMMARY JUDGMENT

The State of California ex rel. State Lands Commission ("California") agrees with the United States that there are no material issues of fact disputed between the parties. Other than matters as to which it has previously requested judicial notice, California does not intend to rely on matters outside of the pleadings. Such additional matters relate to the undisputed fact that the United States Coast Guard recognized California's ownership of the disputed lands by applying to California for use of such lands.

California's statement of the undisputed facts is set forth in its initial motion for leave to file complaint.<sup>2</sup> California will not reiterate such facts here.

California agrees with the United States that the only question is one of law and that in such circumstances this matter is now ripe for determination. California joins with the United States in urging the Court to dispense with reference to a special master. California also agrees with the plea of the United States that the Court enter an order setting down these cross-motions in due course and inviting the parties to file briefs regarding the respective motions.
