3 CHIEF JUSTICE ROBERTS: This special sitting
4 of the Court is held today to receive the Commission of
5 the newly appointed Associate Justice of the Supreme
6 Court of the United States, Neil M. Gorsuch.

7 We are pleased to have with us today the
8 President of the United States. On behalf of the Court,
9 Mr. President, I extend to you, and the First Lady, a warm
10 welcome. We are also pleased to have with us our
11 retired colleague, Justice Stevens. Welcome back.

12 The Court now recognizes the Deputy Attorney
13 General of the United States, Rod J. Rosenstein.

14 MR. ROSENSTEIN: Mr. Chief Justice, and may
15 it please the Court:

16 I have the Commission which has been issued
17 to the Honorable Neil M. Gorsuch as an Associate Justice
18 of the Supreme Court of the United States. The
19 Commission has been duly signed by the President of the
20 United States and attested by the Attorney General of
21 the United States. I move that the Clerk read the
22 Commission and that it be made part of the permanent
23 record of the Court.

24 CHIEF JUSTICE ROBERTS: Thank you, Deputy
25 Attorney General Rosenstein; your motion is granted.

1 Mr. Clerk, will you please read the
2 Commission.

3 THE CLERK: Donald J. Trump, President of
4 the United States, to all who shall see these Presents,
5 Greetings:

6 Know ye that proposing special trust and
7 confidence in the Wisdom, Uprightness and Learning of
8 Neil M. Gorsuch of Colorado, I have nominated and by and
9 with the advice and consent of the Senate, do appoint him
10 an Associate Justice of the Supreme Court of the United
11 States, and do authorize and empower him to execute and
12 fulfill the duties of that office according to the
13 Constitution and laws of the said United States, and to
14 Have and to Hold the said office with all the powers,
15 privileges, emoluments to the same of right
16 appertaining, unto Him, the said Neil M. Gorsuch during
17 his good behavior.

18 In testimony whereof, I have caused these
19 Letters to be made patent and the seal of the Department
20 of Justice to be hereunto affixed.

21 Done at the City of Washington, this eighth
22 day of April in the Year of Our Lord two thousand
23 seventeen and of the Independence of the United States of
24 America, the two hundred and forty-first, by the President,
25 Donald J. Trump. Jefferson B. Sessions, III,

1 Attorney General.

2 CHIEF JUSTICE ROBERTS: I now ask the Deputy
3 Clerk of the Court to escort Justice Gorsuch to the
4 Bench.

12 administer justice without respect to persons --

13 JUSTICE GORSUCH: -- that I will administer
14 justice without respect to persons --

15 CHIEF JUSTICE ROBERTS: -- and do equal
16 right to the poor and to the rich --

17 JUSTICE GORSUCH: -- and do equal right to
18 the poor and to the rich --

19 CHIEF JUSTICE ROBERTS: -- and that I will
20 faithfully and impartially --

21 JUSTICE GORSUCH: -- and that I will
22 faithfully and impartially --

23 CHIEF JUSTICE ROBERTS: -- discharge and
24 perform --

25 JUSTICE GORSUCH: -- discharge and perform

19 CHIEF JUSTICE ROBERTS: Justice Gorsuch, on
20 behalf of all of the members of the Court, it is my
21 pleasure to extend to you a very warm welcome as the
22 101st Associate Justice of the Supreme Court of the
23 United States. We wish for you a long and happy career
24 in our common calling.

25 JUSTICE GORSUCH: Mr. Chief Justice, I want

1 to thank all of my colleagues and all of those who serve
2 in this remarkable institution for the warm welcome I've
3 received. Thank you.

4 THE MARSHAL: The Honorable Court is now
5 adjourned until Monday next, at 10:00 a.m.

6 The Court requests that guests remain in
7 the Courtroom briefly while the President departs and
8 the Bench clears.

9 Thank you.
