# Sample Schedules for Student Groups Supreme Court of the United States

Although the Supreme Court does not offer guided walking tours, visitors are encouraged to tour public portions of the building on a self-guided basis and take advantage of a variety of educational programs, including <u>Courtroom Lectures</u>, a <u>Visitor Film</u>, and court-related <u>Exhibitions</u>. In addition to the Courtroom, portions of the first and ground floors are open to the public. Highlights include the John Marshall statue, portraits and busts of former Justices, and two self-supporting marble staircases. The Courtroom is located on the first floor.

Court sessions, including handing down of opinions, are also open to the public. <u>Courtroom seating</u> is on a first-come, first-served basis. Please see the sample schedules below for ideas on how to structure a visit to the Supreme Court Building for student groups of various sizes.

If a lecture is unavailable on the day of your visit, you may view the film instead. The film runs for 24 minutes. Seating capacity is 50 per theater. Showings are continuous in both theaters to accommodate two groups at the same time beginning at 9:15 a.m. The last showing starts at 3:45 p.m.
